SHIVER-MEGERT REPORT REVIEWED Continued:

AC campuses. Jones referred the Regents to chapter 2 of the plan which summarizes the projected requirements for Amarillo College and presents recommendations for capital projects. In chapter 10 they present a preliminary cost analysis associated with identified projects. Amarillo College does not need many new facilities; we do need to take better care of existing facilities, however. Jones introduced Bruce Cotgreave who been the liaison between AC and Shiver-Megert from the beginning and has been heavily involved with both the internal and external capital needs assessment committees. Cotgreave maintains a master plan for maintenance projects which are integrated into the alterations and improvements budget. Some projects could be pulled out of the Shiver-Megert Master Plan and scheduled for implementation during a budget year and paid out of A & I funds. There was discussion regarding recommended projects on each of the Amarillo campuses. Jones told the Board that the President's Cabinet met and prioritized the projects in the Master Plan and came up with a short list of critical priorities. Escajeda stated that the Board will make the final recommendations and decisions concerning the short list and Master Plan.

Jones discussed different ways to raise the revenue to pay for these needed projects. Following are the various suggestions:

- > private gifts
- > increase in tuition and fees to retire revenue bonds
- continue to cover capital improvements out of A&I budget
- > consider raising tax rate
- > public bond issue
