## **Purpose Statement:**

The Amarillo College Child Development Lab School provides early care and education for children three months to five years old. Admission to the Center is open to children of students, faculty, and staff of the College. Children of parents not connected with the College are admitted on the basis of space availability. The Lab School welcomes families of all socioeconomic, racial, ethnic and religious backgrounds. The Lab School is open to students and faculty for observation and study for educational and training purposes (Last Reviewed fall 2011).

#### Goal Statement #1:

To provide high quality, developmentally appropriate education for children ages three (3) months to five (5) years.

# Objectives/Outcomes (including assessment tools and standards):

After completion of an annual National Association for the Education of Young Children (NAEYC) program review, program will meet 80% of compliance in all 10 Program Standard Areas. If program meets less than 80% on any Program Standard, the program will target criterian within that Standard for 5% improvement.

#### Information on NAEYC Standards

- Standards 1-5: Focus on the advancement of children's learning and development in regard to relationships, curriculum, teaching, assessment of child progress, and health.
- Standard 6: Focuses on the qualification, knowledge, and professional commitment of a program's teaching staff.
- Standards 7 and 8: Focuses on relelvant partnerships established with both families and the community.
- Standards 9 and 10: Focuses on the program's physical environment and the leaderships and management provided by the program administration.

The NAEYC ensures that among other things, children experience a change in knowledge/growth as a result of the Child Lab services. Will send in annual report each summer, documenting how we are maintaining compliance with NAEYC standards. Will not receive another onsite visit until summer of 2014, when we will receive a new score.
