Prepare students to take the national licensure examination for Vocational Nurses (AC Strategic Plan through 2015: Strategy 1.1).

Outcome/Objective Statement

At the completion of the program, 85% of graduating Vocational Nursing students will pass the licensure exam on the first attempt (AC Strategic Plan through 2015: Task 1.1.1).

 - o 2009 Board Pass Rate Data: Numbers =61 out of 63 and Percentage =s 96.83%
 - o 2010 Board Pass Rate Data: Numbers = 71 out of 76 and Percentage =s 93.42%

 The pass rate for 2009 of 96.83 and for 2010 of 93.42 exceeds the program benchmark of 85%.

The National Council of State Boards of Nursing (NCSBN) has increased the rigor of the NCLEX-PN Exam and has implemented an updated test plan. We will align to meet the changes that the BON has implemented. We will increase the rigor of our tests and will increase the benchmark on our ATI testing program to assist with these changes. We have implemented the new Differentiated Essential Competencies which were revised by the BON into our curriculum. These changes align with the new test plan.

Prepare students to meet ATI (Assessment and Technology Institute – assessment and remediation program) comprehensive benchmark.

Outcome/Objective Statement

Prior to graduation, all students will achieve a 60% score on the ATI comprehensive exam as measure by ATI tracking report.

- Results (Provide Numbers and Percentages for Quantitative Data)
 - o **Data:** Numbers=37out of 39and Percentage=s 94% who took the comprehensive predictor in November 2009 scored at or above the 60% program benchmark as measured by the ATI tracking report.
 - Data: Numbers = 31 out of 34and Percentage =s 91% who took the comprehensive predictor in November
 2010 scored at or above the 60% program benchmark as measured by the ATI tracking report.
 - O Data: Numbers = 37 out of 40 and Percentage = s 92% who took the comprehensive predictor in April 2010 scored at or above the 60% program benchmark as measured by the ATI tracking report.
 - Data: Numbers = 43out of 48 and Percentage =s 89% who took the comprehensive predictor in November
 2010 scored at or above the 60% program benchmark as measured by the ATI tracking report.

Analysis

The above data shows that not all students passed the comprehensive predictor with a 60% or higher. Students who did not meet the benchmark were required to remediate and re-test on the material until they met the standard.
