  - o **Intramurals participants Fall 2010 to Spring 2011 Data:** Numbers = 202 out of 263 Intramurals Participants reenrolled in the Spring Semester. Percentage = 76.81% were retained from Fall to Spring.

#### Analysis

 Results show that Intramurals participants in Fall of 2010 were retained at a higher level to the most recent overall college statistics.

Some of the 2010 Fall participants were found not to have been currently enrolled students. # Analysis:

These running results have met our expectations. 2008 FTIC cohort is 64.6% pass rate and 68.6% completion of 7 or more hours. These numbers are considerably lower than those found with the Badger Boot Camp attendees.

Plan of Action: We will continue to hold Badger Boot Camp sessions and encourage more students to register for this activity to complete their New Student Orientation, creating new sessions if necessary. This Goal will no longer be tracked by PET form.
