- Poverty (LuLu Cowan)

 - Discussion regarding how faculty/advisors will know what descriptors led to the student's at-risk score in order to know how best to help the student; task force will consider options
 - Danita and Tamara added that AC may already have some data available that could be used now; Danita's area already has predictive modeling software that could be used
 - o Retention Alert almost 900 alerts for Fall 2012; alerts end up with advisors;
 - Jason is preparing a report on these students for the data specialists and the AtD coaches
 - Integration with Blackboard and Datatel could eventually capture information (grades) in real time and lead to automated alerts
 - Need for additional training what constitutes an alert/what does not?
 - Need to revisit an attendance policy

Primary Interventions

- 1. Student Profile
 - a. Meeting this morning
 - i. Pilot for Fall 2013
 - ii. Identified predictive descriptors for scoring
 - 1. Poverty/Pell eligible, developmental ed., single parent home, 1st generation, high school, minority status, ethnicity, GPA, TSI scores, dual credit
 - iii. We will run a query of descriptors across incoming students
 - iv. Based on number of descriptors students will be assigned an at risk score
 - v. Student score will determine interventions
 - 1. 5 = Advising, FYE, Tutor, mentor, career assessment
 - 2. 4 = Advising, FYE, Tutor, mentor
 - 3. 3 = Advising, FYE, Tutor
 - 4. 2 =Advising, Tutor
 - 5. 1 =Advising
 - vi. We are working on processes for implementation (who will run queries, assign scores, interventions, follow-up)
 - vii. We will present this to the AtD Coaches at our April meeting for their feedback and make necessary adjustments
