We have adopted the attitude of No Excuses and Achieving the Dream and have utilized the resources made available to assist a student who would other drop out of school (Food Pantry, Referrals to Housing and Childcare, awareness of other resources in the College).

We work with WT CJ Professors very well. They come in and recruit/motivate our students and we provide them with a contact early in the process so the student's transition goes smoothly.
