Purpose Statement (With Last Updated Date): To be a center of musical learning and to provide cultural enrichment, service, and collaboration within the community of Amarillo and the Texas Panhandle (last updated 10/6/12)

Goal Statement #1: To fulfill the requirements for the "Texas Field of Study in Music", by providing a Freshman/Sophomore curriculum that prepares a student for transfer to a senior level Music program (AC Strategic Plan through 2015: Strategy 1.7, and No Excuses Plan Goal 5).

Outcome/Objective Statement #1A

Upon completion of each semester, 80% of music performance students will score a 9 or above on a rubric with a scale of 0-12 as measured by a jury of music faculty members.

 - o **2010-2011 Data:** Numbers = 11 out of 14 and Percentage =s 82%
 - o **2011-2012 Data:** Numbers = 17out of 21and Percentage =s 80.9%

 80% goal has been met for past 3 years

Improvements

- List any Improvements Made in the 2011-2012 (Last Academic) Year:
 Included scales as part of jury process for all performers. Instituted minimum amount of performance material expected for each student, sent to all private instructors. Instituted barrier system to prevent students from progressing to next semester of lessons without requisite skills.
- o Evaluate Why Improvements Were Successful/Were Not Successful: The barrier system was designed to identify students who are not making sufficient progress, and to encourage them to change majors, if the faculty as a whole does not believe they will be successful as a professional musician. This barrier worked successfully in that one student, who was not allowed to progress, and who the faculty felt would not be able to successfully transfer and complete a music degree, did change majors.

Upon Graduation or program completion (completing all music requirements but transferring before completing all General Education requirements) 60% on music majors will successfully transfer to a senior institution or obtain a job in a music-related field.

Objective was met in both 2010-2011 and in 2011-2012. In 2011-2012, 3 students opted to complete their general education requirements at Amarillo College, are currently enrolled in the 2012-2013 academic year, and anticipate AC Graduation in Fall 2012 or Spring 2013. Four students successfully transferred to senior institutions: 3 students to West Texas A & M University, and 1 student to University of North Texas.

Students enrolled in Music Appreciation and American Music will take a pre-test at the beginning of each semester, and post-test at end of semester, showing an improvement of 30% or more.

Pre-test average: 51.26% for 155 students. Post-test average: 82.05% for 121 students. Improvement of 31.26%

o **2011-2012 Data**:

Pre-test average: 49.94% for 104 students. Post-test average: 83.39% for 78 students. Improvement of 33.45%
