The meeting was called to order by Mr. Hicks, Chairman. He welcomed all present and asked if there were any public comments. Mr. Forrester gave the invocation.

MINUTES APPROVED:

Ms. Fortunato moved, seconded by Mr. Forrester to approve minutes of the regular meeting of August 28, 2012. The motion carried unanimously.

STUDENT GOVERNMENT ASSOCIATION REPORT:

Ms. Mikhaela Sample, SGA president, reported that there are 30 new SGA members and 10 associate members. They presented a check in the amount of \$7,020 from the Distinguished Lecture Series to the AC Foundation. AC SGA members will attend the upcoming regional convention in El Paso.

EDUCATION REPORT – STUDENT SUCCESS UPDATE:

Dr. Russell Lowery-Hart, Ms. Cara Crowley, Dr. Dan Ferguson, and Mrs. Kara Larkan-Skinner presented a PowerPoint presentation regarding course redesign. Title V, a grant from the U.S. Department of Education, \$3.2 million was awarded to Amarillo College in October 2010; it is a five year grant. The three main activities covered under this grant include: course redesign for English, math, history and biology; stimulate teaching and learning (faculty professional development); and fortify student support (Datatel's Retention Alert and Grade Book). The English courses were showcased at this Board meeting. Course redesign for 22 sections of Comp I and 14 sections of Comp II in English was piloted in spring 2012; 11 faculty participated; approximately 900 students who enrolled in Comp I or II were in a redesigned section. Included in the English course redesign are two goals: increase student success and department consistency. Comp I improvements: Created a Comp I menu of assignments to ensure coverage of appropriate rhetorical, research, and compositional skills. Created an in-class essay final exam. Students were helped to meet these standards by the following: compiled better student writing samples; created better exercises, handouts, and writing lab activities; created active learning techniques; created a Learning Object Repository to house all course materials; and referred more students to the Writers' Corner for additional help. Comp II improvements: created a menu of assignments to ensure coverage of appropriate interpretative, research, and writing skills; and created an in-class analytical essay final exam requirement. Students were helped meet these standards by the same means as Comp I; plus, created a list of culturally diverse reading selections that would appeal to a variety of students. Dr. Ferguson discussed the curriculum required for each course. There has been an increase of 15% in success rate for all students in Comp I & II; a 12% increased success rate in Comp I all students; 19% increased success rate for Hispanic students; 16% increased success rate for Comp II all students; and a 15% increased success rate for Hispanic students in Comp II. The English Department has done a great job of increasing expectations for students and proving leadership for faculty. The pilot redesign program began in math this semester; in the first round of tests 74% of the students received an "A". A success rate is a "C" or better.

BOND CONSTRUCTION UPDATE:

Mr. Richard Constancio, Shiver-Megert & Associates and Mr. Cotgreave presented an update on the current status of bond projects. The Board was presented with an overview of the Byrd Business Building/Parcells Hall first floor renovation and the Lynn Library second floor renovation projects. Mr. Constancio spoke of the enclosed first floor space of the Byrd Business Building/Parcells Hall; there is 11,500 square feet to be used for offices and work spaces. Plans are underway to move Dr. Lowery-Hart's office and Ms. Lemaster's area to the second floor of the Lynn Library; this will leave part of the first floor of the library vacant to be used for a new student center.

AMARILLO COLLEGE BENEFIT PROGRAM EXTERNAL AUDIT:

The external audit of the Amarillo College Benefit Program for the 2011 calendar year has been completed by Johnson & Sheldon, P.C. A copy of the audit was furnished for review. This is an information item only and requires no action. The Independent Auditors' Report found the financial statements referred to in the audit to be presented fairly and to be a clean audit. Net assets available for benefits in 2011 were \$78.7 million; this was down \$4.5 million from 2010. At December 31, 2011, program membership totaled 953, including 19 participants receiving disability and death survivors' retirement contributions.

REQUEST FOR USE OF EARNINGS FROM THE HARRINGTON LIBRARY CONSORTIUM ENDOWMENT FOR PURCHASES TO BENEFIT THE CONSORTIUM APPROVED:

Funds are available in the 2007 Bond Budget and Title V grant.

Dr. Proffer moved, seconded by Mr. Nicholson to approve RFP No. 1272. The motion carried unanimously.

REQUEST FOR PROPOSAL NO. 1277 – NEW CAREER AND TECHNICAL CENTER CAMPUS FOR AMARILLO COLLEGE, MOORE COUNTY APPROVED:

RFP No. 1277, for the New Career and Technical Center Campus at Moore County. Proposal Package included general conditions, site work, building pad, concrete foundation and slab, rebar, structural steel, bar joist, and other miscellaneous steel components. The project will also include masonry, roofing, carpentry, interior finishes, mechanical, electrical, plumbing, landscaping, parking, and other items to complete the construction of this facility.

Project was advertised in the newspaper for sub-contractors and suppliers, by Page & Associates, Inc., Construction Manager-at-Risk (CMR). This project is scheduled to be complete and to have the facility open by fall semester 2013.

Page & Associates, Inc. provides a Guaranteed Maximum Price of \$4,064,599.00.

Funds are available in the Moore County Bond Budget.

Ms. Fortunato moved, seconded by Mr. Nicholson to approve RFP No. 1277. The motion carried unanimously.

USE OF RESERVES FOR HEREFORD HINKSON MEMORIAL CAMPUS APPROVED:

The project construction-manager-at-risk and the architects have worked together to determine the opinion of probable cost for the Everett and Mabel McDougal Hinkson Memorial Campus in Hereford. In order to take advantage of cost savings of concrete foundation and slab and finishout of exterior walls of several additional classrooms, the Board heard a request for use of \$500,000 in college reserves.

Funds are available in board restricted reserves and Hereford Campus reserves.

Mr. Forrester moved, seconded by Mr. Nicholson to approve the use of reserves for the Hereford Hinkson Memorial Campus. The motion carried unanimously.

RFP No. 1278, for the Structural Package for the New Hereford Campus, was advertised in the newspaper for sub-contractors and suppliers, by Page & Associates, Inc., Construction Manager-at-Risk (CMR). Proposal Package included site work, parking lot, building pad, concrete foundation and slab, rebar, structural steel, bar joist, and other miscellaneous steel components. Page & Associates, Inc. provided a price of \$1,203,599.00.

Funds are available in the 2012-2013 Hereford A & I Budget.

Ms. Nelson moved, seconded by Mr. Forrester to approve RFP No. 1278. The motion carried unanimously.

INVESTMENT REPORT APPROVED:

The Board of Regents was presented the Quarterly Investment Report for the period June 1, 2012 through August 31, 2012. A copy of the report was provided to the Regents.

The weighted average maturity of the portfolio is approximately 3.2 months. The overall portfolio yield is 0.268%. During this time frame the portfolio market value has remained consistent at 100%. We are heavily invested in CDs.

Mr. Nicholson moved, seconded by Mr. Forrester to approve the Quarterly Investment Report. The motion carried unanimously.

PRELIMINARY FINANCIAL REPORT ACCEPTED:

The financial statements as of August 31, 2012 are attached at pages 14 through 23.

Revenue

We reached 98% of our total budgeted revenue.

Expenditures

We spent 94% or \$51.2 million of the \$54.6 million amended fiscal 2012 budget.

Auxiliary Enterprises

Bookstores' net profit is \$817,281; and rental properties' net profit is \$1,059,781.

Restricted Funds

Federal grants and contracts have increased \$4.6 million; state grants and contracts are up \$562,231; local grants and contracts are up \$710,219; and KACV grants and contracts have decreased by \$170,119.

Cash and Investments

\$62.0 million total minus \$18.5 million (bond) = \$43.5 million – August 2012; \$44.3 million total minus \$11.8 million (bond) = \$32.5 million – August 2011; \$66.6 million total minus \$24.3 million (bond) = \$42.3 million – August 2010.

Alterations & Improvements

There has been \$1.1 in actual expenditures out of the \$1.6 million projected costs minus Hereford improvements.

Tax Schedule

\$19,277,169 has been collected out of \$18,659,577 budgeted; we are over budget by \$617,592.

Bond Expenditures

There has been \$54.9 million spent for completed projects out of \$66.4 million projected for the Amarillo campuses.

Dr. Proffer moved, seconded by Mr. Forrester to accept the preliminary financial reports. The motion carried unanimously.

PRESIDENT'S REPORT:

The SACSCOC On-site team was on campus September 17-20; AC received a positive and successful exit report. AC was given two recommendations. A written report will be delivered in two weeks.

Dr. Matney reported on his recent trip to Austin for the Legislative Appropriations Request (LAR) Hearing; besides community college presidents, there were staff from the Legislative Budget Board and staff who wrote Senate Bill 1. Those testifying included Dr. Bill Holda, Kilgore College President; Dr. Rey Garcia, TACC President, and Dr. Richard Carpenter, Chancellor, Lone Star College System.

Mr. Hicks and Dr. Matney will attend the West Texas Community College Presidents Meeting on September 26, in Midland to discuss the upcoming legislative package with Senator Seliger.

Dr. Matney will attend a meeting at Hahn, TX, TACC Legislative Agenda training for community college presidents, in Austin on September 28.

Amarillo Opera's production of Madama Butterfly will be presented on September 29 and 30.

The 2012 Higher Education Leadership Conference will be held in Austin on October 4-5; Dr. Proffer and Dr. Matney will be in attendance.

The Wendy & Stanley Marsh Creative Mind Lecture Series on Amarillo by Dr. Gary Nall, will be held on October 4, 12:30 pm, Oak Room, CUB and 7:30 pm, AMoA.
