1. LEGAL CLINIC RECOMMENDATION

WHITE/AUSTIN

Mr. White shared that the funding for the legal clinic has been through a grant to Legal Aid of Northwest Texas from the Mackenzie Scott funds. The data shows that around 30 students have been served in the last two years. Mr. White's recommendation is to not continue with the clinic as the students can go to the Legal Aid of Northwest Texas offices downtown for assistance. Mr. Austin was in agreement and added that he has spoken to the ARC who can refer students to Legal Aid of Northwest Texas for the exact same service as well as faculty and staff if they meet the income thresholds.
