The meeting was called to order by Mr. Nicholson, Chairman. He welcomed all present and asked if there were any public comments. Dr. Woodburn gave the invocation.

# **MINUTES APPROVED:**

Ms. Fortunato moved, seconded by Mr. Forrester to approve minutes of the regular meeting of October 22, 2013. The motion carried unanimously.

# STUDENT GOVERNMENT ASSOCIATION REPORT:

Mario Villarreal, president of SGA, reported on the leadership retreat held in October. SGA helped sponsor a State Employee Charitable Campaign (SECC) event, a pumpkin carving contest, and helped raise \$300. Amarillo College was the regional host for the Texas Junior College Student Government Association Conference on November 8-9. SGA recently hosted an event to discuss the dangers of texting and driving. They are planning activities for the spring.

# SPECIAL ACHIEVEMENT AWARD PRESENTATION:

Dr. Matney presented David Ziegler, Assistant Director of the Physical Plant, with a special achievement award. Mr. Ziegler has worked diligently on bond and special projects. He assisted in setting up the Panhandle Sports Hall of Fame event held at Amarillo College.

INDEPENDENT AUDIT REPORT FOR 2012-2013 APPROVED:

Ms. Lani Hall, CPA, with Connor, McMillon, Mitchell & Shennum, PLLC was at the Board meeting to present the regular audit report for the fiscal year ending August 31, 2013. Amarillo College total liabilities and net position totaled \$193,106,807 for 2013. Copies of the audit were provided to the Board of Regents.

Ms. Hall recently met with Dr. Matney and Mr. Berg regarding the single audit findings; there were six dealing with grants. Auditors requested corrective action plans be written for each find. 1) Five students that graduated during the year were not reported to the National Student Clearinghouse within the 30 days required and two students were missed and not reported at all. Corrective Action Plan: An updated process will ensure an accurate report to the clearinghouse of the graduates will happen the next business day and an additional three times throughout the current term following the initial end-of-term graduate term. 2) Payroll expenditures were charged to the grant subsequent to the end of the grant's period of availability. Corrective Action Plan: Grant accounting and grant compliance have instituted a three-step process to ensure that all costs for a grant is appropriate for the grant. 3) Management override of controls for the Adult Basic Education Innovation Grant and other related state grants. Corrective Action Plan: A shift to a centralized approach to grant management which balances the College's content expertise and grant management authority. The new grant management structure will create a team of management and compliance professionals who fully understand the necessity for documentation required on federal and state grants. 4) Little or no documentation on the student incentive expenses. Corrective Action Plan: The College has implemented a corrective action plan which ensures a heightened level of grant compliance while also maintaining vital project direction from content experts. 5) No documentation is being maintained on student eligibility. Corrective Action Plan: Each grant will have adequate management and support to ensure that all participant records are developed and maintained in a manner that program eligibility will be adequately documented. And, 6) The Year One final program report was filed four days late and the Year Two interim report was also submitted late. Corrective Action Plan: Under the new centralized grant management structure each grant will have adequate management and support to ensure that all grant reporting requirements are submitted on time.

Ms. Hall and Matney communicated all of the single audit findings and corrective action plans to be put into place. A draft of the AC Centralized Grant Management organizational chart was

distributed and discussed. The correction plan for Audit Findings 3, 4, 5, and 6 is attached to the minutes at pages 68 through 71. The corrective plan will allow us better management of all grants, currently 31, to ensure we are in compliance with federal, state, and private funders.

Mr. Forrester moved, seconded by Ms. Nelson to approve the audit report. The motion carried unanimously.

**EDUCATION REPORT – ONLINE LEARNING:** 

Mrs. Patsy Lemaster, associate vice president of teaching and learning, and Mrs. Heather Voran, Instructor and academic specialist of teaching and learning, presented the online learning report. From 2010 spring to 2013 fall student enrollments increased by 1,180 students in hybrid classes. Hybrid courses offered have increased by 72 sections. Online enrollments increased by 949 students, but the number of traditional courses decreased by 124 sections. The number of student enrollments in online courses increased by 289 students; 50% of AC students are engaged in online learning. Thirteen programs are 100% online; 24 programs are 80% online. As students get more comfortable with online courses the more online courses will become available. Students enjoy instructor accessibility through email and the Blackboard program. There are detailed instructions for assignments for technology use. There is easy functional course navigation. Students in online courses learn student engagement strategies and active learning techniques. Students use social networking to interact with their instructors, i.e., email, discussion, chat, etc. Interaction between students and faculty and students with other students is practiced. There is timely feedback, external support services and supplemental resources. The next steps for online learning will include vision for online student success, comparative data review of online/hybrid/traditional courses, will conduct an internal/external needs analysis. form student focus groups, seek faculty and administrative input, conduct an infrastructure assessment, and include in institutional strategic planning.

# 2012-2013 ANNUAL GRANTS REPORT:

Mrs. Teresa Clemons, Assistant Chief of Advancement, Grants Development, presented the 2012-2013 Annual Grants Report which is attached at pages 72 through 75. During FY 2013, Amarillo College received \$6 million; an additional \$1.7 million in cash equivalent support was also received. Sixteen grants were awarded (7 state, 1 federal, and 8 local/private); two of the seven state awards were Merit Awards; two private grants were declined.

SALE OF COUNTY PROPERTY OBTAINED THROUGH SHERIFF'S SALE ACCEPTED:

Properties foreclosed for taxes and sold at a "Sheriff's Sale" must sell for a minimum bid which is the lower of the adjusted value or the taxes due plus costs of the sale. In some cases this puts the price above what people will pay at a "Sheriff's Sale." Those properties which do not sell are then held in trust by the county/school tax office. The law provides that they can be offered for sale by sealed bids or auction without a minimum bid at a later date. A listing of those properties and additional information is attached at pages 76 through 79. Board approval is required because the properties are held in trust by Potter County. The Potter Tax Assessor/Collector recommends acceptance of these bids as this puts the property back in production and on the tax rolls. The motion should authorize the Chairman of the Board of Regents to execute the Tax Deeds transferring these properties to the successful bidders.

Dr. Proffer moved, seconded by Dr. Woodburn to accept and authorize the chair of the Board of Regents to execute the Tax Deeds. The motion carried unanimously.

ORDER OF ANNEXATION APPROVED:

Attached at pages 80 through 97 are Orders for Annexation of Territory to Amarillo Junior College District; maps and exhibits showing the area are also included. The City of Amarillo has annexed tracts of land lying adjacent to and adjoining the City of Amarillo, Texas. It was recommended that these territories be annexed to the Amarillo Junior College District.

Dr. Woodburn moved, seconded by Dr. Proffer to approve the aforementioned territory annexation. The motion carried unanimously.

INTERLOCAL AGREEMENT WITH TEXAS INTERLOCAL PURCHASING SYSTEM (TIPS/TAPS) APPROVED:

Pursuant to Chapter 791 of the Texas Government Code, Amarillo College desires to enter into an Interlocal Agreement with TIPS/TAPS. Region VIII Education Service Center and The Interlocal Purchasing System (TIPS/TAPS) Program have entered into an agreement to provide cooperative purchasing opportunities to public agencies. Attached at pages 98 through 101 is a Resolution authorizing the Board Chair to execute the Interlocal Agreement, and a copy of the Interlocal Agreement to be executed.

It was recommended the Board approve the attached Resolution and Interlocal Agreement allowing Amarillo College to contract with TIPS/TAPS. This Interlocal Agreement will allow us to participate in purchasing goods and services competitively awarded by the network.

Ms. Fortunato moved, seconded by Dr. Woodburn to approve the Resolution and Interlocal Agreement allowing Amarillo College to contract with TIPS/TAPS. The motion carried unanimously.

APPRAISAL DISTRICT DIRECTORS VOTING ADOPTED:

Attached at pages 102 through 105 is a resolution and a ballot casting votes for the members of the Board of Directors of Randall County Appraisal District and a resolution and a ballot casting votes for the members of the Board of Directors of Potter County Appraisal District.

AGREEMENT BETWEEN AMARILLO COLLEGE AND AMARILLO AREA ADULT LITERACY COUNCIL APPROVED:

The retirement of the Amarillo Area Adult Literacy Council director, Elaine Basham, has given Amarillo College and the AAALC the opportunity to improve and revise the partnership agreement. AC will no longer be the fiscal agent for AAALC. AAALC will vacate the house on Van Buren in which they have officed for space on the third floor of the Lynn Library. A copy of the agreement between Amarillo College and Amarillo Area Adult Literacy Council is attached at pages 106 through 109.

Dr. Woodburn moved, seconded by Mr. Mize to approve the agreement between Amarillo College and Amarillo Area Adult Literacy Council. The motion carried unanimously.

# • <u>Communications and Technology Infrastructure Purchases for Renovation of College Union</u> <u>Building, Dutton Hall, and Moore County Campus Student Activity Center</u>

New communications and technology equipment is required to equip the planned remodels of the Washington Street Campus College Union Building and Dutton Hall, and the Moore County Campus Student Activity Center as identified below.

College Union Building technology requirements for network switches, computers, telephones, audiovisual equipment, and other miscellaneous components have been identified to not exceed \$110,000. Funds available are provided by the 2007 Bond Project.

BIDS AND PROPOSALS Continued:

Dutton Hall technology requirements for network switches, computers, telephones, audiovisual equipment, and other miscellaneous components have been identified to not exceed \$275,000. Funds available are provided by the 2007 Bond Project.

Moore County Campus Student Activity Center technology requirements for network switches, computers, telephones, audiovisual equipment, and other miscellaneous components have been identified to not exceed \$55,000. Funds available are provided by the Moore County Campus A&I Funding.

Administration recommends using the recently awarded contract to <u>Lubbock Audio Visual</u>, <u>Inc (L.A.V. Amarillo)</u>, dated September 1, 2013, and approved by the Board on August 27, <u>2013</u>. General Datatech LP (GDT) acquisitions <u>are available through The Cooperative</u> <u>Purchasing Network (TCPN) and State/DIR purchasing cooperatives approved by Board</u> <u>resolution in 1993</u>. The Dell computers are available through the <u>State of Texas Department</u> <u>of Information Technologies (DIR) contract</u> with Dell.

This request directly applies to Goal 4: Ensure the College's Future, and more specifically, strategy 4.1: Connect planning and budgeting, and strategy 4.6: Commit the College to technology which attracts and retains students and enables effective and efficient College operations, from the Amarillo College Strategic Plan through 2015.

Ms. Fortunato moved, seconded by Dr. Proffer to approve the Consent Agenda. The motion carried unanimously.

FINAL PAYMENT – MATH OUTREACH CENTER DEVELOPMENT AT DURRETT HALL, WASHINGTON STREET CAMPUS APPROVED:

Approval for final payment in the amount of \$3,000.21 for the project listed above was requested. Construction Manager-at-Risk, Page & Associates, Inc. provided a Guaranteed Maximum Price of \$512,102.00. The final cost for the project is \$424,401.21. A contingency in the amount of \$37,259.00 has been credited back to Amarillo College, along with a savings of \$50,441.79.

Mr. Forrester moved, seconded by Ms. Nelson to approve final payment for the Math Outreach Center development at Durrett Hall. The motion carried unanimously.

REQUEST FOR CHANGE ORDER – 2007 BOND PROJECT, UPGRADES TO MUSIC BUILDING APPROVED:

A Change Order in the amount of \$68,278.00 is requested. This work will include adding HVAC to the Data Room in the Music Building in the amount of \$15,507.00. This request will also include new landscaping and irrigation on the North and East sides of the Amarillo Museum of Art in the amount of \$52,771.00.

Funds are available in the 2007 Bond Budget.

Ms. Fortunato moved, seconded by Ms. Nelson to approve the request for change order for upgrades to the Music Building. The motion carried unanimously.

FINANCIAL REPORT ACCEPTED:

The financial statements as of October 31, 2013 are attached at pages 110 through 119.

# <u>Revenue</u>

We have received 25% of revenue budgeted or \$14.6 million.

# Expenditures

Institutional support has decreased by \$1.8 million. We received the check from the insurance company to cover the hail damage.

# Auxiliary Enterprises

Bookstores' profit is \$12,835. Rental properties' net profit is \$246,667.

# **Restricted Funds**

Federal grants and contracts have decreased \$160,801; state grants and contracts have decreased \$302,245; local grants and contracts have increased \$213,481; and KACV grants and contracts have increased \$43,965. Resident instruction has decreased \$127,750.

# **Cash and Investments**

\$45.5 million total minus \$5.6 million (bond) = \$39.9 million – October 2013; \$54.2 million total minus \$16.9 million (bond) = \$37.3 million – October 2012; \$45.2 million total minus \$9.5 million (bond) = \$35.7 million – October 2011.

## **Alterations & Improvements**

\$235,089 has been spent out of total A&I/Land Improvements without branches. \$143,000 has been spent out of the Moore County Campus projected cost of \$815,000; and \$422,000 has been spent for the new Hereford Campus completion.

# Tax Schedule

\$458,018 has been collected out of \$20,556,126 budgeted.

### Bond Expenditures

There has been \$4.3 million spent on Moore County Campus out of \$4.7 million budgeted.

Ms. Nelson moved, seconded by Mr. Forrester to accept the October 2013 financial reports. The motion carried unanimously.

# **PRESIDENT'S REPORT:**

There were 148 Amarillo High School 2012 graduates who enrolled at Amarillo College. The number one feeder school, Caprock, had 186 who attended AC; Palo Duro had 132; and Tascosa had 125. Fifty-nine percent of 2012 Amarillo metro graduates enrolled at Amarillo College.

Amarillo College was awarded the higher education giver award in the community. AC increased by 6% givers with 44 new givers. There were 178 employees who gave \$52,000 to United Way. AC loaned executive, Pam Madden, was named Loaned Executive of the Year.

**PRESIDENT'S REPORT Continued:** 

Four watercolors were bequeathed to Amarillo College by the estate of Ed Jaquet. Jaquet, a 1951 AC graduate, bequeathed his paintings to the college in honor of his faculty mentor, Dr. Clarke Garnsey, who was the head of the Amarillo College Art Department.

Amarillo College was awarded a Downtown Amarillo, Inc. Spearhead Award for Urban Design for the Downtown Campus parking lot design.

Dr. Matney recently testified at the State Board of Education Conference regarding House Bill 5 and its impact on high schools and community colleges.

Dr. Matney, along with regents Nicholson and Mize, attended the Higher Education Leadership Conference, Nov. 21-22, in Austin. Mr. Nicholson served on a panel while in attendance.

The Energy Cost Savings Subcommittee of regents Forrester, Hicks, Mize, and Woodburn will meet with representatives from Cynergistic and then discuss privately any other options on December 4.

**REGENTS' REPORTS, COMMITTEES, AND COMMENTS REGARDING AC AFFILIATES:** 

Panhandle PBS will host their winter pledge drive the first week of December.

Ms. Fortunato distributed a 2013-2014 season calendar of events for the Amarillo Museum of Art.

CONSULTATION WITH AMARILLO COLLEGE ATTORNEY REGARDING A PERSONNEL MATTER:

At 8:50 p.m., Mr. Nicholson announced there would be a closed meeting to afford an opportunity for the Board to consult with attorney, Mark White, regarding a personnel matter, in accordance with Texas Government Code Section 551.074.

At 9:59 p.m., Mr. Nicholson called the Amarillo College Board of Regents meeting back into open session. Ms. Fortunato moved to uphold determination made by Dr. Matney regarding a grievance filed by Matt Craig, Associate Professor, Biology, against Dr. Kathy Wetzel, Department Chair, Mathematics & Engineering. Dr. Woodburn seconded the motion. The motion carried unanimously.

Amarillo College Schedule of Findings and Questioned Costs Year Ended August 31, 2013

#### Finding 2013-003

Views of Responsible Officials and Corrective Action Plan:

Amarillo College (AC) fully understands the seriousness of this finding and the severity of potential impact it has on the institution. Immediately upon being briefed concerning this and other audit findings, the AC President proactively initiated a corrective action plan that will ensure that all managerial controls are identified and followed, pursuant to Amarillo College policy.

The primary focus of the corrective action is a shift to a centralized approach to grant management which balances the College's content expertise and grant management authority. This approach will add additional layers of internal safeguards and controls. The main features of the new centralized structure include:

- 1) Establish a position of Senior Director of Grant Management (SDGM) with the primary purpose of daily over-sight of all AC grants to avoid any conflict of interest and ensure internal controls. All federal and state grant project directors/coordinators will be jointly supervised: 1) by the SDGM position for grant compliance, fiscal management, and required documentation; and 2) by the internal content expert(s) for grant programmatic direction. The SDGM will conduct monthly meetings (at a minimum) with the grant project directors/coordinators to offer guidance; to verify that all deliverables and reports are being accomplished in a timely manner; and that all documentation is being adequately maintained. A special emphasis will be placed on budgetary issues including preapproval of budget amendments; review of eligibility requirements and documentation; and overall budget management.
- 2) The Adult Basic Education Innovation Grant (ABEIG) along with other related state grants represent a unique structure within AC's grant management system. While most grants have an independent purpose and dedicated grant funded personnel, the ABEIG family of grants all have an interwoven purpose with very few dedicated grant funded personnel (which contributed to the issues identified in the audit findings). As an additional corrective measure, the new centralized structure will include a full time dedicated grant coordinator position that will provide grant management support for all of the ABEIG related grants. The internal content expert(s) will provide program design and delivery. The grant coordinator will take care of the day to day budget management, grant documentation, and management of grant timelines and other requirements. This grant coordinator position will report directly to the SDGM.
- 3) The SDGM will report directly to AC's Chief of Planning and Advancement, thus creating the centralized structure. Grant development and grant compliance are located in the Division of Planning and Advancement and will continue to provide critical compliance oversight. The grant management structure will continue to closely coordinate with the Grant Accounting office (see attached grant management organizational chart).

- 4) Recommendation for an AC Board of Regents policy statement to be included in the AC Board Policy Manual which identifies the aforementioned changes and mandates that the managerial controls for grant management must be followed. All grant project directors/coordinators, all internal content experts assigned to grant projects, and immediate supervisors for the grant related personnel will receive a grant management orientation and will sign an acknowledgement that they will abide by the policy statement.
- 5) This new, centralized grant management structure will provide a process in which grant compliance questions will be reviewed and resolved through a collaborative approach. When consensus for compliance issues cannot be achieved at the grant management/project content expert level, AC's Chief of Planning and Advancement will be responsible for advancing the issue to the appropriate AC senior leadership and facilitating the joint effort to resolve questions regarding grant internal controls. In every instance that a grant compliance issue reaches the senior leadership level, the President will be apprised of the issue and the final resolution.

The new grant management structure creates a team of management and compliance professionals who fully understand the necessity for (and the level of) documentation required on federal and state grants.

Specifically addressing the Recommendation cited for Finding 2013-003, the President has met with all senior leadership to impress upon them the "impropriety of management override of control." This message will also be communicated to all grant project directors/coordinators, and all internal content experts assigned to grant projects. As a follow-up, the President will recommend a Board of Regents policy statement to be included in the AC Board Policy Manual which mandates that the managerial controls for grant management must be followed. All grant project directors/coordinators, all internal content experts assigned to grant projects, and immediate supervisors for the grant related personnel will receive a grant management orientation and will sign an acknowledgement that they will abide by the policy statement.

The President's corrective action plan provides two additional layers of management and safeguards for the cited grant and the other related state grants. Moreover, with the addition of an extra layer of safeguards for <u>all</u> federal and state grants, the centralized approach will strengthen the overall management and compliance process.

#### Finding 2013-004

.

Views of Responsible Officials and Corrective Action Plan:

Amarillo College (AC) has implemented a corrective action plan which ensures a heightened level of grant compliance while also maintaining vital project direction from content experts. This collaborative approach will improve grant management accountability for all grants. The primary change is a shift to a centralized approach of grant management which balances the College's content expertise and grant

management authority. This approach balances the expectations of internal safeguards and controls with assurance that AC's viability and sustainability is accomplished. *Please see full description of new centralized grant management structure under the response to Finding 2013-003*.

In reference to the questioned costs cited in Finding 2013-004, AC will reimburse the funding agency (if requested) from institutional funds.

Specifically addressing the Recommendation cited for Finding 2013-004, the President has met with all senior leadership to impress upon them the "impropriety of management override of control." This message will also be communicated to all grant project directors/coordinators, and all internal content experts assigned to grant projects. As a follow-up, the President will recommend a Board of Regents policy statement to be included in the AC Board Policy Manual which mandates that the managerial controls for grant management must be followed. All grant project directors/coordinators, all internal content experts assigned to grant projects, and immediate supervisors for the grant related personnel will receive a grant management orientation and will sign an acknowledgement that they will abide by the policy statement.

In addition to the emphasis on the Board policy adherence, the new centralized approach will strengthen the overall management and compliance process. Grant accountability will be increased for all grants, and the new, centralized grant management structure provides a process in which grant compliance questions will be reviewed and resolved through a collaborative approach. When consensus for compliance issues cannot be achieved at the grant management/project content expert level, AC's Chief of Planning and Advancement will be responsible for advancing the issue to the appropriate AC senior leadership and facilitating the joint effort to resolve questions regarding grant internal controls. In every instance that a grant compliance issue reaches the senior leadership level, the President will be apprised of the issue and the final resolution.

Views of Responsible Officials and Corrective Action Plan:

Immediately upon being briefed concerning this and other audit findings, the AC President proactively initiated a corrective action plan that will ensure that all managerial controls are identified and followed, pursuant to Amarillo College policy.

Under the new centralized grant management approach (*please see full description of new centralized grant management structure under the response to Finding 2013-003*) each grant will have adequate management and support to ensure that all participant records are developed and maintained in such a manner that program eligibility will be adequately documented.

In reference to the questioned costs cited in Finding 2013-005, AC will reimburse the funding agency (if requested) from institutional funds.

Specifically, the ABEIG grant will have a new full time dedicated grant coordinator assigned to provide management support. The grant's internal content expert(s) will continue to play a vital role in providing program design and delivery. The grant coordinator will take care of the day to day budget management, grant documentation <u>including participant files</u>, and management of grant timelines. This position will report directly to the Senior Director of Grant Management.

The new grant management structure creates a team of management and compliance professionals who fully understand the necessity for (and the level of) documentation required on federal and state grants. It also allows the grant content experts to concentrate on the advances in education that are achieved through the work of the grants.

Since the Senior Director of Grants Management will provide oversight for the timely submission of all grant reports, late submissions will be avoided via this corrective action plan. The only late submission of a grant report that will be permissible is one in which the grant funding agency has provided written permission of a revised submission date prior to the original due date for the report.

The new grant management structure creates a team of management and compliance professionals who fully understand the necessity for timely submission of reports required on federal and state grants.





AN ORDINANCE OF THE CITY OF AMARILLO, TEXAS ANNEXING ADJACENT AND CONTIGUOUS TERRITORIES, AS DESCRIBED IN EXHIBIT A TO THE CITY OF AMARILLO, TEXAS; FINDING THAT ALL NECESSARY AND REQUIRED LEGAL CONDITIONS HAVE BEEN SATISFIED; PROVIDING THAT SUCH AREAS SHALL BECOME A PART OF THE CITY OF AMARILLO, TEXAS AND THAT THE OWNERS AND INHABITANTS THEREOF SHALL BE ENTITLED TO THE RIGHTS AND PRIVILEGES OF OTHER CITIZENS AND BE BOUND BY THE ACTS AND ORDINANCES NOW IN EFFECT AND TO BE HEREAFTER ADOPTED; FURTHER PROVIDING FOR AMENDING AND CORRECTING THE OFFICIAL BOUNDARIES OF THE CITY OF AMARILLO, TEXAS AS HERETOFORE ADOPTED; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING FOR SAID ORDINANCE TO TAKE EFFECT AND BE IN FORCE FROM AND AFTER ITS PASSAGE.

NOW, THEREFORE, BE IT ORDAINED BY THE City Commission of the City of Amarillo, Texas, THAT:

SECTION 1. All of the above premises are found to be true and correct and are incorporated into the body of this Ordinance as if copied in their entirety.

SECTION 2. The property described in Exhibit A, which are attached hereto and incorporated herein for all purposes, be and is hereby annexed and brought within the corporate limits of the City of Amarillo, Potter and Randall County, Texas, and same is hereby made a part of the City.

SECTION 3. The service plan, attached hereto as Exhibit D and incorporated herein for all purposes was submitted in accordance with Chapter 43 of the Texas Local Government Code and is hereby approved as part of this Ordinance, and is made a part hereof.

SECTION 4. The property described in Exhibit A shall beer its pro rata share of the taxes levied by the City, and the inhabitants of this area herein annexed shall be entitled to all of the rights, privileges, and responsibilities of other citizens of the City and area hereby bound by all acts, ordinances and all other legal action now in full force and effect and all those which may be hereafter adopted.

SECTION 7. The City Manager is hereby directed and authorized to file a certified copy of this Ordinance with the necessary governmental agencies.





SECTION 5. In the event this ordinance or any part hereof is found to be invalid, such invalidity shall not affect the remaining portions of the ordinance, and such remaining portions shall continue to be in full force and effect.

SECTION 6. This ordinance shall become effective from and after its date of final passage.



The purpose of the TIPS/TAPS Program shall be to obtain substantial savings for participating school entities or public agencies through cooperative purchasing.

This Agreement contains the entire agreement of the Parties hereto with respect to the matters covered by its terms, and it may not be modified in any manner without the express written consent of the Parties.

If any term(s) or provision(s) of this Agreement are held by a court of competent jurisdiction to be invalid, void, or unenforceable, the remainder of the provisions of this Agreement shall remain in full force and effect

The Parties to this Agreement expressly acknowledge and agree that all monies paid pursuant to this Agreement shall be paid from budgeted available funds for the current fiscal year of each such entity.

Before any party may resort to litigation, any claims, disputes or other matters in question between the Parties to this Agreement shall be submitted to nonbinding mediation

No Party to this Agreement waives or relinquishes any immunity or defense on behalf of themselves, their directors, officers, employees, and agents as a result of its execution of this Agreement and performance of the functions and obligations described herein.

This Agreement may be negotiated and transmitted between the Parties by means of a facsimile machine and the terms and conditions agreed to are binding upon the Parties.

## AGREEMENT BETWEEN AMARILLO COLLEGE AND AMARILLO AREA ADULT LITERACY COUNCIL, INC.

This agreement is **effective on December 1, 2013** and between Amarillo Junior College District (AC) and Amarillo Area Adult Literacy Council, Inc., a Texas non-profit corporation (AAALC).

Now therefore, in the consideration of the mutual covenants contained herein, the parties do hereby agree as follows:

### I. Purpose of Interagency Agreement:

The purpose of this agreement is to establish the best possible cooperative method of providing high quality services to meet the educational needs of illiterate adults in the Amarillo/Canyon area as a means to help themselves, their families and the community, and to enhance the potential for these persons to enroll at AC and successfully complete AC programs.

It is the intent of this agreement to:

- Define the services to be provided by each party;
- Ensure that eligible adults receive high quality, appropriate educational services within the mission of AAALC;
- Ensure that each party assumes the responsibility to communicate with the other, and share leadership responsibilities and by doing so ensure that available resources are utilized in the most effective manner;
- Ensure that this cooperative arrangement between AC and AAALC is developed, implemented, and reviewed at least annually; and
- Define the parties' financial obligations.

#### II. Description of Program

AAALC serves illiterate adults within the Potter/Randall Counties area by providing volunteer tutors to teach reading and writing skills. From time to time, AC refers adults to AAALC and accepts students who have received these services. AC and AAALC will share responsibilities and resources to ensure that this mutually beneficial program will continue. This agreement will be effective only after the AC Board of Regents adopts a resolution to the effect that this program serves a public purpose, supports the mission of AC, and clearly benefits AC.

#### **III. Agency Responsibilities:**

#### A. Responsibilities of AAALC:

- 1. Carry out the mission of AAALC as provided in its Articles of Incorporation.
- Be responsible for the selection and employment of its executive director and all other employees, and be solely responsible for all salaries, benefits, insurance if any, payroll taxes and other incidents of employment.
- 3. Maintain oversight, supervision and control over its executive director, volunteer and program, including tutor training, student acceptance criteria, and program design.
- 4. Reimburse AC monthly for the cost of copies at the current internal rate charged departments (At this time, the rate is  $6\phi$  per page black and white;  $17\phi$  color).
- 5. Provide AC an annual report detailing the number of students served, the types of services, the enrollment history at AC, and other details that AC may reasonably request.
- Notify AC should the governing board of AAALC vote to change its mission, dissolve, hire or fire employees, or sue or be sued.
- Cooperate with AC to agree on other details as needed to accomplish the purpose set out in paragraph II above.
- Pay to AC its accrued debt for past rent and salaries, as soon as reasonably possible. This amount is \$19,506.35 as November 1, 2013.
- 9. Reimburse AC monthly for the cost of Retiree Health Insurance Premium for benefit of Elaine Basham.

#### B. Responsibilities of AC:

- 1. Provide tutoring space for 4 5 daily tutoring sessions in appropriate space on the third floor of Lynn Library on the Washington Street campus or in the ACcess Learning Center, ESL lab, or AVID center.
- 2. Assist AAALC in moving to the library, and provide furniture as available.
- 3. Provide IT support and the use of 5 computers located as described in paragraph 1 above.
- 4. Provide reasonable access to copiers/scanners.

- 5. Provide shared support staff at the library. Two AC employees will be available during normal business hours to assist AAALC and its tutors.
- 6. Provide assistance for grant writing.
- 7. Provide access to Lynn Library during normal AC business hours.
- 8. Cooperate with AAALC to agree on other details as needed to accomplish the purpose set out in paragraph II above.

### IV. FERPA

In rendering performance hereunder, if applicable AC will ensure compliance with all applicable statutory requirements relating to the confidentiality of education records set forth in the Family Education Rights and Privacy Act (FERPA), 20 U.S.C. §1232g. et. Seq. AC will have a system in effect to protect student records that are maintained in connection with the services provided pursuant to this agreement. AC will not transfer or disclose any identifiable student education records to any third party or entity without the express written consent of someone authorized to act on behalf of the child. AC understands and agrees that no confidential information will be disclosed in any document intended for public disclosure.

#### V. Immunity

Nothing herein shall be deemed to constitute a waiver of any immunity which may be asserted by AC.

### VI. Relationship of Parties

Nothing herein shall be construed in any manner to create a cause of action for the benefit of any person not a party to this agreement, or to create any rights for the benefit of any person not a party to this agreement not otherwise existing at law. Nothing in this agreement is intended to create a contract of employment between AC and any AAALC employee. The parties to this agreement are independent, and this agreement is not intended to create a joint venture between the parties.

#### **VII.** Insurance

Both parties to this agreement shall carry workers' compensation insurance, comprehensive general liability insurance and directors officers' liability insurance.

### VIII. Term

This agreement will be for a term of two (2) years but may be renewed. The agreement may be modified from time to time by action of each party's governing board. Either party may terminate

this agreement by giving 90 days written notice. AAALC's indebtedness, if any, to AC shall service the termination. The Commercial Lease Agreement dated May 1, 2008 and the Agreement dated December 2, 2008 between the parties are both terminated on the effective date of this agreement.
