Housing and Stipend payments for March

Hello all,

I have been getting a lot of calls concerned with the monthly stipend for March so, let me try to explain it (it's confusing).

The VA will only pay for the actual days of the term with, the addition of more 8 week sessions this will reflect in your pay so, you might want to think about and prepare for that as you plan your future semesters. AC will be implementing more 8 week sessions so, obtaining a 16 week term isn't possible but may be limited.

Here is an example of what this semester may look like for most of you. Remember that the shorter the term the less hours you need to receive full time pay so, 16 wk term=12hrs is full time, 8 wk term=6 hrs and it prorates down to ¾ and ½ time.

2016 SPRING TERM SCENARIO 1

1/19-5/13/16 (16WKS) 6 HOURS ½ TIME

1/19-3/11/16 (8WKS) 3 HOURS ½ TIME

3/12-3/19 SPRING BREAK HALF TIME PAY FOR THE 16 WK TERM ONLY

3/21-5/13/16 (8 WKS) 3 HOURS ½ TIME

Should be considered full time except for the spring break week where the terms overlap. March's pay will not reflect a full months check because one term ends and another begins a week later. The week of spring break you are still enrolled 6 hours that began in January and ends in May so they figure that week in to the pay.

Scenario 2

1/19-3/11/16 6 hrs full time Not enrolled from 3/12-3/19 = no stipend 3/21-5/13/16 3 hrs ½ time

The only full month of pay will be February and April because you are enrolled the entire month.

Other than attending conferences for training I have a manual that the VA created for School Certifying Officials. I have provided a small paragraph that explains how we (certifying officials-Kelly Murphy) are supposed to report hours. This manual is available for everyone to view on the veteran website (link provided below) so, please feel free to look up anything you would like answers to.

Summer Terms and Nonstandard Enrollment Periods

Standard quarters are 10 to 13 weeks in length and standard semesters are 15 to 19 weeks in length. Standard quarters and semesters adhere to the school's academic calendar. When a session or course doesn't follow this standard format, certify the actual begin date, end date, and credit for the session or course. Courses taken during a defined session—an eight week summer session, for example—should be certified from the beginning date to the ending date of the session if the courses start the first week and end the last week of the session. 
