3. AC APP Kleffman

Currently, AC's app is the Ellucian Go app. The quote for an AC mobile app is \$15,000 + \$12,000 for services. Thereafter, \$2,600 yearly charge. We would then need a staff person to implement it and then have it validated by the app store before it could be an AC branded app. This app would allow us the ability to add our own applications. Students would be able to register and pay, view full calendars and maps, link to bookstore, etc. without having to go through a web browser.

Cabinet didn't see that we would get much more other than branding of our own AC app. It was noted that only about 40% of students pay online. There may be other options that are outside of Ellucian. Students use the Blackboard app to access their classes. Some suggestions for promoting Ellucian Go included having Communications and Marketing develop an email and card for advisors to use with students; having faculty and staff walk students through the process of downloading the app or create a simple YouTube video showing students how to download and use the app.

It was suggested that a focus group of students be selected to prioritize our online presence and get a sense from them what's more important and useful to them.

Cabinet decided to not make a change and this time, and AC will instead use what we currently have via a strong promotion of the Ellucian Go app. AC will then get feedback and usage data on what works and what doesn't. Terry will check into usage data for the Blackboard app.

4. DATA Witherspoon

We submit different data 3 times each year to IPEDS. Currently submitting information on 12-month enrollments July 1, 2015 through June 30, 2016 (unique headcount). Collin reviewed his data on the CIP codes for all awards. He is working on getting it into the Leadership Report Card. It already includes equity and male/female breakdown and the breakdown for Levels I, II, and Associates degree. It was noted that each CIP code may have multiple levels of awards and that it could also include several programs, e.g. CIS. Internally, we may want the data broken down further but separate from IPEDS data so as not confuse the two. IPEDS is the foundational data point used by Achieving the Dream and Aspen. Programmatic data can be pulled from IDS.

Low Hispanic completion rates were noted and it was suggested that there is a need to match high enrollments with completion data to see if there is an equity issue. This may change with Pathways due to General Studies students, however which pathway a student takes will not be in the data. We do not receive credit for dual credit transfer.

Collin is in the process of writing a data dictionary. The Report Card will have programmatic data which should reflect where there are low enrollments.

Quality Matters is already going on with course redesign and will be used for online course redesign. There will be a master course shell with a peer review committee for these courses.

We now have clear data that is leading the conversation and an IR approach that allows for conversation. We have fixed the foundation of IR. Now we can move on with predictive modeling.

NOTE: **During the Cabinet meeting, Teresa Clemons, Claudie Biggers, and a group of students interrupted to announce that AC had just received news that we have received an HSI Stem grant in the amount of almost \$5M from the US Department of Education. This grant will do many things including building a greenhouse conservatory, adding one new certificate, four new associate degree options in Biology, and a Bachelor's degree option through an articulation agreement with Texas Tech. Food grown in the conservatory will go to the food pantry. The announcement will be made tomorrow.

5. ENROLLMENT UPDATE

Austin

Bob reviewed the handout he provided to Cabinet and noted the following:

- Ethnicity the percentage who self-identify as white continues to decline compared to 2012 (down 50%); number of Hispanic students remains about the same but the percentage goes up as the percentage of white students goes down
- Enrollment by type of major is unchanged
- Increase in full time enrollment; number of students enrolled in 7 − 11 hours is down while those enrolled in 4 − 6 hours is up, likely due to 8 week courses
- Still adding students for the second 8 weeks
- Up almost 2% compared to last year
- With the expansion of the ACE Program to Tascosa, the number of ACE students in the pipeline has actually been limited.
