### **FEBRUARY 10, 2004 MINUTES**

Moller moved, seconded by Crawford, to approve the February 10, 2004 minutes as submitted. The motion carried.

#### REVIEW OF ACADEMIC POLICIES AND INFORMATION/DEGREES AND CERTIFICATES

Byrd noted that at the next meeting we will review the Admission Policies. SACS mandates that this committee review the above and admission policies annually.

#### Academic Policies and Information

Byrd reviewed the proposed changes which included:

- 1. Adding a statement about the Texas Common Course Numbering System
- 2. Adding a statement under Attendance about courses delivered electronically
- 3. Revision to Final Examinations statement.

#### Degrees and Certificates

Byrd reviewed the proposed changes which included:

Austin moved, seconded by Sloger, to approve the changes as presented. The motion carried.

#### **BUSINESS DIVISION**

#### **Computer Information Systems**

Sloger expanded on the rationale for the changes. The advisory committee has endorsed the changes to update, refine, and/or change the indicated courses and programs. Part of the reason for the changes is that we may be spreading the CIS majors to thin and we need to improve the preparation of our students in the workforce. Sloger said they work with the WTA&MU articulation.

Bellah asked if these types of programs are competitive with programs offered through schools like the University of Phoenix. Byrd said he would like many of our programs to work towards such.

Sloger and Fike discussed Math for Business Decisions and agreed that MATH 1324 will meet the prerequisite of MATH 1342 which is required in the Computer Business Specialist Option.

# **Mass Communication**

#### **Radio-Television**

Pirtle noted that the changes are due to the approval of the Field of Study for Communication. Byrd explained that a few years ago the legislature demanded that the Coordinating Board create a field of study that will satisfy the lower-division requirements for a bachelor's degree in a specific academic area at the general academic teaching institution. About 10 fields of study curriculum have been designed.

- 7. Revise the Advertising/Public Relations, Journalism, and Mass Communication/Radio-Television Options to align with the Communication Field of Study curriculum
- 8. Increase the number of hours under Recommended Courses from 1-3 to 5-6 hours Proposed changes for Radio-TV:
  - Revise the Radio-Television AAS Broadcast Production and Broadcast Sales and Marketing options to delete RTVB 1329 and add COMM 2339
  - 2. Change RTVB 1447 to (4 sem hrs; 2 lec, 4 lab)
  - 3. Change BUSI 1311 (expired course) to MRKG 2333

# **LATE WITHDRAWALS**

Byrd has obtained data from Brice. There were 69 faculty who submitted late withdrawals which is an improvement over fall 2002 where were 114 faculty requesting such. Many of the 69 were justifiable.

35 withdrawals were granted after finals had begun and 9 have been granted since January 1, 2004.

### LATE REGISTRATIONS

Brice noted that we also have a slight problem with faculty registering students for a class at the time they turn in grades. Usually the student had been dropped for non-payment.

Byrd noted that the 12<sup>th</sup> class-day rosters were returned in a timely manner this semester.

ADVISORS, ADVISING, DEGREE PLAN CHANGES, ETC
Usnick distributed a memo of concern that has arisen in his area regarding the above. Bellah noted that these types of concern could be covered under the Best Practices which are being worked on, Academic Integrity, and Ethnics statements.
