# ACADEMIC AFFAIRS COMMITTEE February 8, 2005 MINUTES

## HEREFORD BANCH CAMPUS

The topic of the Hereford Branch Campus was on the agenda for the members to discuss endorsement of opening such with the understanding that it be self-sustaining financially and that it along with the Moore County Campus pay the 8 percent indirect cost back to the institution.

Enrollment went from about 125 Dumas student attending Amarillo College to 265 enrolling at the Moore County Campus the spring it opened. There are now about 358 students attending the Moore County Campus. Hereford is renovating an old elementary school building which will have 9 classrooms and a multi-purpose room. At Moore County the taxing district is Moore County whereas at Hereford it will be the Hereford ISD District.

Matney moved, seconded by Johnson, that the Academic Affairs Committee endorse Amarillo College opening a campus at Hereford effective Fall 05.

## ALLIED HEALTH DIVISION

## **Dentist Aide Program**

Crawford noted that a recent ruling has impacted the immunization criteria for several programs.

The request was to restructure the program's clinical hours to meet the immunization criteria.

- Delete DNTA 1166 and DNTA 1167 from the course offerings and major course requirements
- 2. Add DNTA 1266 to the course offerings and major course requirements.

Austin moved, seconded by Hays, to approve with noted corrections.

#### **EMSP**

Request was to delete the following courses which were added to the catalog several years ago and have never been offered.

EMSP 1208: Emergency Vehicle Operations EMSP 1209: Emergency Medical Dispatching

EMSP 1314: Non-Emergency Transport

EMSP 1358: Street Sense

EMSP 2137: Emergency Procedures

EMSP 2345: EMS Supervision/Management

Bellah moved, seconded by Graff, to approve the request. The motion carried.

#### **Medical Data Specialist**

Crawford noted that changing the requirements noted in the introductory paragraph will bring this program in alignment with the other Allied Health programs. After discussion it was agreed to change the request to read, "A grade of C or higher is required for satisfactory completion of all courses. To continue in the program a student may repeat a required course only one time, and may repeat no more than two required courses while enrolled in the program. The term "repeat" shall be interpreted to mean re-enrollment following withdrawal, drop or an unsatisfactory grade from a class."

It was also noted that in the curriculum outline "General Education" should read, "Major Course Requirements"

Requested changes in prerequisites of:

POFM 1264: Practicum

MDCA 1220: Administrative Procedures I

POFM 1313: Medical Terminology I

Hays moved, and the motion was seconded, that the requests with noted changes be approved. The motion carried.

## **Respiratory Care**

The committee reviewed the requested changes:

- 1. Changes in the Practicum are due to the immunization ruling
  - Delete RSPT 1163: Clinical Respiratory Therapy Technician
  - Delete RSPT 1166: Practicum I Respiratory Therapy Technician
  - Add RSPT1266: Practicum I Respiratory Therapy Technician
- 2. Add the following statement to the introduction: "A grade of "C" or better is required for satisfactory completion of all courses in the Respiratory Care curriculum.
- 3. Request to add "... and take the National Board for Respiratory Care entry level examination..." Crawford believes they are trying to address the

issue of students procrastinating taking the exam. There is a two year limit to do such. There was discussion as to whether it is philosophically correct to require sitting for the national exam and how to manage the requirement of such for graduation without tying it to a course. Bellah suggested that the requirement be tied to one of the last courses students take and give them an option such as write an extensive research paper or sit for the exam.

4. Change/Add the following courses:

RSPT 1101 from (1 sem hr; 1 lec, 2 lab)

Add RSPT 1266: Practicum I – Respiratory Therapy Technician

RSPT 1167 – Change prerequisite

RSPT 2266 Change prerequisite

Byrd took the prerogative of the chair to table the request to require National Exam testing for Respiratory Care and Mortuary Science (which he has also received).

Hays moved, seconded by Graff, to approve the above requests except requiring students to take the National exam. The motion carried.

Bellah moved, seconded by Johnson, to approve the requests as submitted. The motion carried.
