MINUTES

Sloger moved, seconded by Brasher, to approve the February 22, 2005 minutes as submitted. The motion carried.

BEHAVIORAL STUDIES DIVISION

Child Development/Early Childhood

Munger expanded on the rationale to change CDEC 1357 to CDEC 2307 – WECM mandated. The course is required in:

Crawford moved, seconded by Powell, to approve the request as submitted. The motion carried.

INDUSTRIAL AND TRANSPORTATION TECHNOLOGIES

Diesel Mechanics Technology

Lee expanded on the rationale:

1. Delete the Basic Mechanic Certificate
2. Revise the Diesel Technician Certificate
Delete: DEMR 1313 and DEMR 2348
Add: DEMR 1421, DEMR 1442, and DEMR 1329
Change total hours from 36 to 41

It was noted that the listed optional CVOP courses are academic courses which are no longer offered. Lee and Hays said that when appropriate they would advise students to take the Continuing Education CVOP courses. They encourage diesel mechanics students to have truck driving experience.

Hayes moved, seconded by Graff, to approve the requests with the above noted change. The motion carried.

Industrial Maintenance Technology

Hayes expanded on the rationale for the requested changes. The changes will bring basic electrical class into program to control content for program specific requirements and control scheduling. It will also replace basic mechanical course that was lost when AC circuits increased to 4 hours. Courses will also be updated to utilize more accurate descriptions. The request also combines two courses with same content from different specializations. Everything is built around 4 hour blocks – 2 lec, 2 lab.

Munger moved, seconded by Sloger, to approve the requests as submitted. The motion carried.

Safety and Environmental Technology

Lee expanded on the rationale for the requested changes. They are trying to increase the enrollment and advance the program. After reviewing the program, it was determined that the requirements for the program far exceeded those of other technical programs. As such, they were not able to recruit students who would otherwise be excellent candidates. Review of similar programs gave them direction in the choice of courses that would better prepare students for employment in the field or continuing on to a four-year institution.

Add the following new courses: EPCT 1317 and SCIT 1302 to course offerings

AAS

1. Delete: BIOL 2401, MATH 1316, PHYS 1301, PHYS 1101
2. Add: ENGL 2311 (After discussion it was agreed to change ETWR 2301 to ENGL 2311), EPCT 1317, and SCIT 1302

Certificate

1. Major Electives – Add Options of: EPCT 1317 and SCIT 1302

Graff moved, seconded by Hays, to approve the requested with noted change. The motion carried.

Welding

Hays expanded on the rationale for the requested changes. He noted it has been difficult to schedule the required contact hours. Most programs in the area are all day programs whereas our students are mostly working students attending night classes.

Hays noted the request for the AAS program is being withdrawn at this time.

The request is to change from one certificate to two:

Basic Welding - WELD.CERT.BAS – 16 hours

Advanced Welding - WELD.CERT.ADV – 32 hours

With the new format, students can attend both day and night classes and obtain the advanced certificate in one year.
