The winter terms were studied (feasibility, cost, enrollment and other factors). This year 80% of the students were current AC students. Last year the number was 90%. This is good. The winter term is targeted to draw non-AC Students. There are enough contact hours and income to continue offering the winter term with the current enrollment numbers.

The contact hours for Spring semester are down. Being in a base year, these were not the results hoped for.

We are anticipating another award from the Rapid Growth Fund. It looks like the award will be approximately \$202,000, down from last year=s amount.

The four day work week proposal has been discussed by Executive Committee several times. There is not enough information to make a good decision at this time.

There are three bills in the Legislature that have the potential to directly affect AC. The appropriations bill determines our funding. There is a Aclean up@ bill to complete the ATC property transition. Senator Swinford has submitted a bill to transfer the ATC property directly to AC=s ownership. Other bills that indirectly affect AC have to do with TASP, ERS, and insurance.
