Guest Presentation: Patsy Lemaster, Aimee Martin, Monique Dupuis, Becky Burton, Lee Colaw: LMS Features of MyAC

The presenters addressed concerns related to the LMS features of MyAC. Due to overlap and confusion caused by MyAC and AC Online, the College has decided to discontinue LMS features of MyAC. Multiple discussions of this issue that included three faculty members who are heavy users of MyAC have led to this decision. Patsy reported that the following groups were also consulted: Registrars, Advising and Counseling, TIC, IT, Help Desk, Ask AC. According to reports from the Academic Technology Council, due to the timecruiser contract timeline there was no time to inform that committee.

December 31st is the day the MyAC LMS tools will be disabled. The Senate held an extensive discussion regarding the issues related to the change, the issues surrounding it and the methods that will be used to disseminate the information.

Dr. Matney has chosen the selection committee, which includes six faculty members. This will be a national search.

6. Faculty Blog

Claudie brought up the idea of creating a faculty blog, which will be hosted offcampus.

7. Rank & Tenure Policies

Policy has not been updated since 1994. Claudie asked that the senators share the policy with their divisions

8. Policy Update on Online Culture

Claudie brought up that many AC policies are not related to online faculty and their unique needs.
