Call to order: Danita McAnally called the meeting to order at 2:04 pm

Review of minutes: Danita McAnally asked the committee to review the January 11, 2006 meeting minutes. Committee indicated that the minutes were accurate.

Presentation of Proposed Self-Study: McAnally presented the proposed self-study approach which was shared with the Vice President's Council. She reported that everyone on the Council was supportive of the new approach.

McAnally asked everyone to review the edited self-study forms. No errors were found.

McAnally asked if the forms were ready to be passed on to the President's Cabinet for final approval. Mark Hanna made a motion to pass. Richard Pullen seconded that motion. Motion passed unanimously.

Update the Institutional Program Review Policy and Procedures: McAnally discussed the changes that will need to be made to these policy and procedures the committee agreed to the changes and asked her to make the updates.

Benefits of new process for Program Review Self Study:

1. Number of hours involved in creation of self-study will be much less.
2. Focuses on analysis and resulting improvements.
3. Requirements of external entities provide criteria for the assessment.
4. Automation of statistics allows for focusing on analysis.

5. Web-based approach allows for embedding links to the requirements and other relevant documentation.
6. Provides a systematic integration of outcome assessments, PET forms, past Program Reviews, and budgeting. Closes the loop for institutional effectiveness.

SACS Update: McAnally stated the next SACS reaffirmation of accreditation visit will be in 2013. We will start preparing for their visit in 2011. McAnally also received an e-mail from SACS that had proposed changes (shift in numbers and word changes). She will wait until after December to see if these rhetorical changes approved before updating the Program Review Self-Study form's additional information sections.
