Ex-Officio Member Reports  Report Member  Vice Pr Acader Burton Instruct		Report from the Program Manager	CDEC enrollment is down due to COVID19. Students report that they have no childcare for their own school age children making it difficult for them to attend courses. To support the students the program has alighned course offerings in a two year cycle. This will alllow cohorts to develop and better tracking of progress by advising, Texas Workforce Commission and employers. CDEC also is making curriculum changes to strenghten content as requested by the group during the 2019-2020 advisory meeting.

New Business	2021 Curriculum Committee Recommendation	Proposed Changes to the CDEC.AAS  1. Remove CDEC 1313 and CDEC 2341 from the Major Course Options list. These courses have not been taught at AC because they have not made with a minimum requirement of 12 students. Having them on the options section is confusing to the students, advisors, and instructors.  2. Move CDEC 1321 and CDEC 2328 into the Major Course Requirements section and remove the Major Course Options section.  3. This will move from 39 to 45 Hours for Major Course Requirements  Proposed Changes to the CDEC Certificates  4. Remove CDEC 1313 and CDEC 2341 from the Paraprofessional Certificate requirements because these courses are not taught at AC. Having them on the required list of courses are confusing to the students, advisors, and instructors. On the current degree plan, it will always leave the student 6 hours short of obtaining a Paraprofessional Certificate. By removing these 6 hours, it will take the required hours to achieve a Paraprofessional Certificate from 40 hours to 34 hours.  5. Because of it being a stackable certificate, those above two certificates are in the Administrator Certificate requirements, but currently there is a course missing. We need to add into the Administrator Certificate CDEC 1359 Children with Special Needs. Currently that certificate sits at 42 hours, but by putting that CDEC 1359 course on the list, it takes the certificate up to 45 Hours. It does not really require the student to take an additional 3 hours because they already took that course in the Para Certificate. The 45 Hours combined to get all 3 certificates is now equal to the Major Course Requirements of 45 Hours. To finish out an Associate's Degree, the student has to take 15 core hours.		
		Tina Maloney made a motion to move forward with taking this to the Curriuclum Committe, Jill Goodrich made a 2nd, and all approved.		
	New Certificates and Degree's	The department is moving to a "cohort" model so that students go thru classes together and become a more cohesive group.		
	New in 2020-2021	Tina Maloney with TWC reported that she is awarding about half of the scholarships that she has in the past, but has 5 new students on the list for Spring 21. There is a change to the Texas Rising Star rating for the director to have an Associates degree.
