Health Science Advisor Report	Javier Herrera – working with current students on Spring 2021 registration. Making sure they have everything ready. Will start working with HS students soon to make sure they are ready for next fall. New Health Sciences Advisor replacing Sandra – Jessica Sanchez. She will start attending the meetings with Javier.	
Student Report	Mallery Warden – Mallery mentioned several of the resources that are available to students such as the ARC, Counseling Center and tutoring. Mallery does tutoring for 1 st year students. Mallery also thanked Dr. Byrd for taking time to teach the students in Nuclear Medicine.	
Director's Report	<p>Tamra Rocsko – Tamra Welcomed the committee and thanked them for attending. She explained that students have to read with a Physician and Dr. Byrd has helped with this, and that Dr. Cussuto (the new Nuclear Medicine radiologist) may be reading with the students as well. He welcomed this and has enjoyed his interactions with the students. Tamra talked about the COVID policies being different at each facility. Tamra and Kayla talk to the students to make sure they know that they have to comply with each facilities policies.</p> <p>*New Strategic Plan – still focusing on completion rates. Current rate is at 56%.</p> <p>*Additional focus on transfer students and 80% by 2025 completion. Five</p> <p>*Components of the Strategic plan: Completion, Degree Alignment, Learning, Equity, and Financial.</p> <p>*Maria is still the student we serve...age 27, single, working two jobs, more than one child.</p> <p>*Amarillo College was ranked as one of the 10 finalist for the Aspen Award. If we win we would get a share of the 1 million dollar prize. We should find out spring 2021.</p> <p>*Russell Lowery-Hart has started the Anti-Racism institute. There is a committee of about 30 employees. They will be looking at minority completion rates.</p> <p>*Kayla has been vital for helping with the clinical sites.</p> <p>*Mallery is also a tutor and works part-time in the Nuclear Med. Lab. Mallery will be taking her boards soon.</p> <p>*Medical Term. Boot Camp – Tamra noticed in the last two capstones students were struggling with terminology so they are developing the Boot Camp to help.</p> <p>*There will also be a Physics and Instrumentation Boot Camp for 2nd year students. John with Covenant in Lubbock will be working with the students. Hoping this will help with pass rates on Capstone.</p> <p>*Accreditation – Self-Study is due in 2021. Will be asking Clinical sites for information.</p> <p>*Student Travel – Trip in April is still on track in San Antonio. Students raised a lot</p>	

	<p>of money to help with the trip. Will not have to pay very much out of pocket. Student Life also helps with some funding because Nuclear Medicine has the student club.</p> <p>*Pass rates 100%</p> <p>*Employment rate is 100%. Two students decided not to work in the Nuc. Med. Field.</p> <p>*Smart Watches – students are not allowed to have phones while in clinicals. Are students allowed to wear smart watches as long as they are used appropriately? Tamra asked for a vote on this. All Committee members present voted yes, students can wear them if used appropriately. (Tiffany, Lindsey, Christy, Marilyn, Deedra).</p> <p>*Handbook – COVID Policies – Tamra stated that students must follow the Clinical Site policies.</p> <p>* Kayla mentioned that Ramiro Sanchez with Covenant has been letting student's complete PET rotation there. It has helped out and is very appreciated. The clinical sites in Amarillo have been accommodating with our students.</p>	
Affiliation Reports	<p>Tiffany Stevens – CT Northwest TX. Hosp. – Tiffany mentioned that the students in clinicals now are doing great. Most patients are COVID and student don't help with those so there may be a concern in getting comps since most CT patients are currently COVID positive. Tamra also mentioned that the general CT patients that are not positive must be going to outpatient imaging for their CT exam and we may need to look at affiliation agreements with those sites so that the students that general diagnostic CT experience and comps. We will re-assess this in the Spring.</p> <p>Christy Ramirez – Veteran's Admin – No issues, students are doing great</p> <p>Lindsey Hagemeier – Baptist St. Anthony's Hosp. – Students are doing great. No complaints.</p> <p>Marilyn Glidewell – Northwest TX. Hosp. – Students are not able to go in the COVID rooms.
