I spoke with Jennifer this morning. I think this might be a great way for us to dip our toes in with WW to see what our employee response would be.

We could subsidize the WW Digital membership by 50%, so employees would pay \$28 for a 3-month membership.

I like Craig's estimate of 100. We could buy 100 blocks from WW @ \$56 each. We could advertise for employees to join at \$28 per 3/month membership and payroll deduct their membership fees. We could even subsidize it more if employees paid for a whole year in advance, maybe instead of \$112, they only pay \$84. We could track over time to see if we would want to purchase more blocks based on utilization.

Process for getting employees codes:

- 1.) Employee purchases code(s)

- 2.) Craig is emailed purchase details
- 3.) Order is checked to verify it is an employee purchasing code(s) & to make sure max code purchase has not been exceeded (max 4 per employee)
- 4.) Craig/Karen assign code to employee (Cheryl forwarded updated codes list yesterday)
- 5.) Code is marked off & emailed to employee with instructions (attached)

Let me know if I've missed anything. Also, please look at the attached PDF and make sure it is clear or if there's anything I need to add. I tweaked it from the original to make it reflect our process a bit more.
