## REQUEST FOR STATEMENT OF QUALIFICATIONS NO. 1406-ABBREVIATED AGREEMENT BETWEEN OWNER AND CONTRACTOR FOR CONSTRUCTION PROJECTS WITH LIMITED SCOPE APPROVED

RFQ 1406, for the construction of the Hereford Campus track for training student truck drivers, was advertised in the Amarillo Globe News on March 24, 2024, and March 31, 2024. Project documents were obtained by five (5) contractors with four (4) contractors submitting proposals. The bid table is attached at page 166.

Mr. Sharp informed the Regents of the numerous complaints from the people who live near the truck driver training track regarding the dust and noise coming from it. He requested that the award be granted to Grading Solutions Excavation and the approval of the Abbreviated Agreement between Owner and Contractor for Construction Projects with a Limited Scope.

This project would be paid for with proceeds from the Hereford fund balance.

Mr. Mize moved to approve the award of RFQ 1406 to Grading Solutions Excavation and to approve the Abbreviated Agreement between Owner and Contractor for Construction Projects with a Limited Scope. Mr. Betancourt seconded the motion. The motion carried unanimously.

### SELECTION OF FINALIST FOR THE POSITION OF COLLEGE PRESIDENT

This item was placed on the agenda in order for the Board of Regents to select a sole finalist for the position of College President.

### **CLOSED MEETING**

Ms. Carlisle announced that with no motion to select a sole finalist for College President, the search was closed and may be revisited at a later date.

Dr. Woodburn moved to adjourn the meeting. Mr. Barrett seconded the motion. The motion carried unanimously. The meeting adjourned at 7:24 p.m.
