Advisor Report	Amanda Mckee – Amanda stated they have registering students for spring classes. It looks like there will be more students this spring. Pam mentioned students have been put in courses on the Dumas campus that are not required in the PTA program. Some advisors might need more training.

Building B Simulation Center	John Smoot – Director Simulation Center – John mentioned the old building B will be a simulation center for Health Sciences. We will be able to hold various events at the building. There will be multiple rooms where faculty can watch students simulate patient care. There will be a home setting that is not ADA compliant and a standardized patient room.  Krystal stated they have five people that will be paid to act out their medical condition. Respiratory and OTA will also be using standardized patients. Joe Chris – One Chair at a Time – Joe mentioned he has friends that are amputees. They might be good standardized patients. Situations can be videoed and then shown to the students.			
Dean of Health Sciences	Kim mentioned the Health Sciences Application process. We plan to have several application meetings. Mandatory for students who are interested in a Health Sciences Program. Sue stated she usually receives about 80-90 applications. Most are qualified. Sue stated PTA is capped at 24 students per CAPTE. Several programs will use Casper this year to interview the students. We are paying for 75 students to interview for various programs. Students will be required to take the HESI Exam again in Spring 2025 when the application opens. Students will not be able to apply unless they have completed A&P I. We will have a google site with step-by-step application process instructions.

Also, is the SFPT starting to use AI generated Program information. Sue stated there are 185 questions for the NPTE and it takes the same amount of time. Sue stated in 2001 there was a 26% reduction in PT reimbursements. One PT mentioned they owe \$15,000 for college. They are not making enough money to pay. Sue stated there was person from Ohio that stood up against United Healthcare and was able to get reimbursements increased.  Audrey Lamberson - Dumas Physical Therapy – Audrey mentioned they are taking one student at each location. There are three AC PTA graduates working in Dumas. They also have a fulltime PTA in Amarillo and Canyon. Audrey stated the students are doing much better.

Sue Presented the Program goals. Sue also talked program pre-regs. There are 6 courses, Engl 1301 (changing to PTHA 1201 two lecture/one lab combo; PSYC 2314, SPCH 1315 or SPCH 1321, a 3-hour Language, Philosophy, Culture, or Creative Arts. Biol 2401 and BIOL 2402 (A&P I and II). Proposed Change...adding Medical Terminology HITT 1205 as a prerequisite for A&P I and II. Sue mentioned she has to stay at 66 hours per her accreditation. PTA Program Sequence and changes. 1st Fall Semester (Accepted into the PTA Program) PTHA 1201 – we will not lose contact hours. Eleven semester hours is considered parttime. Students feel they are fulltime students. They work on homework on the weekends. Kim stated expectations have changed in the workplace. The "Grit" Book was talked about; might use this in FYS. In the spring, PTA is piloting 1<sup>st</sup> Learning Framework, 2<sup>nd</sup> Medical Terminology. Ernesto (student) stated he did not take Medical Terminology but feels it would be good to take prior to getting into the program. Sue talked about the Simulation Center. She mentioned that there will be immersive rooms. Abigal mentioned she shadowed at a clinic. It was very beneficial. Helped her prepare for the rigor. The question came up as to shadowing being required. Ernesto also completed shadowing. Job shadowing requirement stopped when COVID hit. Rena stated it is hard to schedule job shadowing. Several mentioned observation/shadowing is good. Sue mentioned the last few years have been different. Students drop, don't show up.... Students have to have the right mindset before coming into the program. Sue stated the new sequences for class will be better. Lec/Lab combos are more flexible and increase contact hours. Pam stated that adding Lab was great...more techniques. Wes mentioned that PT/PTA interaction is in the class. At times lines might be crossed between PT and PTAs. When the simulation center is open, maybe work on interaction. Sue recapped changes...adding two hours for Med Term, need one hour in final semester, Change hybrid three to two. Keep most of class. This will change the technical part of the program to 44 hours instead of 46. Sue stated she needs a vote from the committee on the changes. She can also send an email to the members who were not at the meeting. Russell made the motion to accept the changes in curriculum. Rena 2<sup>nd</sup>. All approved. Sue talked about PEAT proposed Exam assessment is 75 or above to pass the course. **Sue reviewed Completion Information** – Improve persistence, Increase, completers, Decrease time-to-Completion. Graduation and Retention Rates – Fall of 2024 dropped to 59.09% from 81.25% in Fall of 2023. Licensure Pass Rates and Employment Rates – 1st time pass-rate in Spring of 24 46.2%, Licenses/employed as a PTA within 6 of graduation Spring of 2024 100%. Sue and Pam will be working with CTL to remap courses to improve curriculum.


