Takeaway – different situations, not a lot of running around to different areas. Get to sit with Radiologist. Carly Lewis – Amarillo Heart Group – Carly stated they took three students. Students got to see ECHO, Vein, and Vascular. They are all doing good. Students will get a lot of experience scanning at AHI. Sandy stated AC is doing more vascular. They also like ECHO. BSA has offered ECHO internships. Bonnie Enos – Amarillo Diagnostic Clinic – Bonnie stated the 2 nd year students have been excellent. The summer students didn't seem like they got the scanning. Clinical sites let Sandy know there were issues and they were given extra work to help with additional labs. Tim Hightower – Childress Regional Medical Center - Tim mentioned that some students have very strong personalities. Tim stated the 2 nd year student is doing very well.				

Kaylee Murray – Moore County Hospital District – Kaylee stated they do a little of everything. They just received ECHO Certification. Sixty percent of their scans are OB. Students have been very motivated.

Amanda McGill -Baptist St Anthony's Hospital — Amanda stated she enjoys teaching the students. She has told them if they want to learn things, get up and learn. Some of the students are not motivated. For the most part they are eager to scan. Amanda is letting them scan more.

Rashonda Pena – Northwest Texas Hospital -1st for students? She has enjoyed having them. Need to make sure students are comprehending what they are being taught. Rashonda stated Jaylen is doing great...she sets the bar high. Students need to watch what the techs are doing. Clinical sites can come talk to the students.

Program Director Report

Sandy Parker – Sandy mentioned she is using a QR code for comments.

Completion Rates -

Sandy stated she might take 15 students in the future. Would possibly need to add help. Sandy mentioned that the majority of her students stay in the panhandle. 95% of the sonographers in the panhandle come from Amarillo College. Taking SPI in the summer. One student has already taken the test. ARRT – students have to take test before they can move on. ARDMS – five are in ECHO, one passed abdomen last week. Curriculum – added Medical Terminology back as a pre-req. Physics will start in spring 2026...adding an hour to make two hours. Sandy added several things to curriculum. Sandy would like to have someone teach ECHO. Hopefully, Sonography will be moving to the new Health Sciences Simulation Center in the Fall of 2025.

Applications – Last year at this time received 206 applications. This year received 52 applications. Sandy stated that they have had a good turnout for the application meetings. She recommends students complete shadowing. Working nights – some students have said they don't want to work nights. Interviews – helps with attrition. Trying out the interview process with a company. One interview, everyone gets a grade. Freshman – 0 drops. Kim Boyd – Kim stated MLT is first come first served. She mentioned she is not a fan of the tutoring for the HESI. We need to be able to see where the students are without tutoring. Students taking one class at a time is a problem. Sandy stated top 24 applicants will be considered.

Lab changes – added proficiencies and added sites.

VA Hospital told Sandy they would not be able to take students if the program is not accredited. It is a lot of work to get accredited. Students would have to be with a registered tech. It was mentioned that Sandy runs the Sonography program as if it was accredited. She completes yearly reports, has good pass rates and has QEPs. Students now have to do ARRT. If accredited clinical sites get CE hours.

Tim Hightower stated the pros for being accredited outweigh the cons. Kim Boyd mentioned there could be budget constraints, no extra pay. Kim talked to the Associate VP about accreditation and the thought is it would be better to add ECHO instead of accreditation. There is a lot of money going into the Simulation Center for Sonography.

Clinical Coordinator	Alicia Guzman – Alicia introduced herself to the group and gave her Bio. Alicia mentioned new clinical sites: Lubbock, Plainview, Open Air MRI. Getting feedback every week from sites. Please let Alicia know if the questionnaire is ok. Comps: students are graded on 1 st it is what it is. Please make sure students are actually comping. Will work on getting comps in Trajecsys soon and work on being more efficient. Evals – QR Code???, site evaluation at the end of rotation. Logs – please log everything in Trajecsys.


