DISCUSSION:

1. CREDIT ACCUMULATION AND GENERAL EDUCATION Witherspoon

Mr. Witherspoon presented data related to general education students:

- Full-time students complete at a higher rate; 80% if full-time in their first year
- 63% of black student are part-time and only 10% complete with a degree
- · Minority students struggle to obtain credits within their first year
- Encouraging students toward full-time enrollment is critical

Full-time enrollment is 12 hours/semester and 6 hours in the summer. Cabinet discussed the length of summer course offerings.

General Studies students make up less than 10% of AC students and are generally full-time. Half are not PELL eligible, most are female, and most are first time in college. The retention rate for general studies students is 70-75%. Approximately 20% of them change to another major. Students who are non-degree seeing or undecided are put into the General Studies program until they select a major.

Action Items:

- Mr. Witherspoon will pull data on how many students are enrolled in 15 hours or more per semester.
- Mr. Witherspoon will pull data on students enrolling in summer courses.
- All summer courses will move to the eight-week course model.

2. FOODS TRUCKS IN THE MALL AREA
