# FBI LEOKA Training Program

Law Enforcement Officers Killed & Assaulted  
Officer Safety/Street Survival Training



## Offered at NO Cost to all Law Enforcement

The FBI's Law Enforcement Officers Killed and Assaulted (LEOKA) program is a nationwide law enforcement safety initiative. Ongoing research is dedicated to our nation's law enforcement professionals who continue to make many sacrifices in serving and protecting society. The FBI-LEOKA Safety/Street Survival Training program is designed to assist law enforcement managers, trainers and personnel in the identification of training issues for the purpose of preventing the deaths and/or serious injuries of law enforcement personnel. This program is based on more than twenty years of research by the FBI in collaboration with local state, and federal law enforcement agencies throughout the United States.

This program provides information on the history and policy relating to the LEOKA (Law Enforcement Officers Killed and Assaulted) Program. Also provided are in-depth analyses of three studies which were concluded in 1992 and 1997, which resulted in the publications, *Killed in the Line of Duty* and *In the Line of Fire*. The objectives of these studies were to identify elements in certain situations which led to the ultimate felonious deaths and serious injuries of police officers. The emphasis of the presentation will be focused on the final companion study which was concluded in 2006, and resulted in a publication

entitled "Violent Encounters." This study examines 40 incidents where police officers survived life threatening attacks. Demographic and behavioral descriptors for the victim officers and the offenders were developed and will be presented. The findings and resulting safety training issues will be presented.

Mr. Timothy S. Reid (Tim) has been in law enforcement for the past 30 years. He began his police career as a patrolman in the Township of Little Falls, New Jersey. He then joined the ranks of the New Jersey State Police. Reid entered on duty with the FBI in 1985 and was assigned to the Dallas Division Reactive. He was transferred to the Amarillo Resident Agency where he remained for 19 years. In March 2005, he was promoted to Supervisory Special Agent for the National Data Exchange (N-DEX). In July 2006, he was appointed by FBI Director Mueller as Unit Chief of N-DEX. In September 2008, Unit Chief Reid was transferred to the Law Enforcement Online (LEO) Unit at CJIS, where he spearheaded an initiative to take LEO international and bring LEO into the 21<sup>st</sup> century. Mr. Reid retired on May 31, 2011 ending a 26-year career with the FBI. He now serves as a consultant to the FBI and instructs the LEOKA program.
