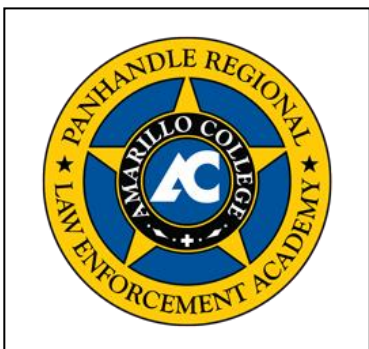
C.I.P.S. – Critical Incident Peer Support:

This course is designed for individuals in the fields of military and/or law enforcement who wish to provide assistance to their PEERS following a critical incident etc. The course was developed out of necessity due to the differences in the military and law enforcement cultures as compared to other first responder cultures. Participants will learn to identify and provide assistance to these individuals in the areas of stress management and critical incident response by providing the necessary tools to assist him/her in resiliency and recovery. This course will provide insight and understanding to the different reactions exhibited by individuals in these high stressed populations and the ways to encourage and interact with them through individual and/or group assistance. This model encourages true peer support while recognizing the difficulties in trying to get individuals together more than once for assistance. This multi-component crisis intervention model will also place emphasis on line of duty deaths and the specialized component for dealing with these emotionally-charged events while also including family support! There is no pre-requisite training required for this course.

Susan Lewis Simons is the President and Founder of Under the Shield, Inc. and Under the Shield Foundation, and is deemed to be one of the nation's leading subject matter experts in the area of Law Enforcement and Public Safety Stress and Critical Incident Response.
