

AMARILLO COLLEGE FOUNDATION Honors Nancy and John Kritser AT 55TH ANNUAL MEETING

The 55th annual Amarillo College Foundation meeting was held September 19th on the second floor of the College Union Building on the Washington Street Campus. Nancy and John Kritser were the special honorees this year.

Trevor Caviness, the Amarillo College Foundation board chairman, opened the meeting. He introduced Dr. Russell Lowery-Hart who spoke of the many accomplishments of Amarillo College over the past year; Amarillo College was named a "Great College to Work" by *The Chronicle of Higher Education*, AC hired the firm Parkhill, Smith and Cooper to develop a Master Plan for the college which includes updating resources, technology and ADA compliance for all the campuses among other things. He discussed the partnership between Amarillo College, AISD, Amarillo Economic Development Corporation and the Amarillo Area Foundation to create the THRIVE scholarship for AISD graduating seniors to attend Amarillo College for free for up to four semesters. The THRIVE scholarship will pay for tuition, books and fees.

Mark Logsdon, Nominating Chairman, gave the 2018-2019 nominating report and thanked the committee for all of their hard work. He introduced the new incoming board members; Greg Graham, Chris Jensen and Katie Oppliger. AS THE 2018 DISTINGUISHED ALUMNUS




GREG GRAHAM

CHRIS JENSEN



Chris is an attorney with Sprouse, Shrader Smith PLLC. Chris served on the Rotary, Amarillo West Board from 1997-2016 and as President in 2015. He was a Leadership Amarillo & Canyon graduate in 2002-2003 and served on the St. Andrews School Board of Directors, 2005-2014. While on the St. Andrews School Board

he served as Treasurer in 2009 and Vice President of the board in 2008 and 2011. Chris is also a member of the Litigation Counsel of America, Panhandle Producers & Royalty Owners Association, Amarillo Area Bar Association, Amarillo Young Lawyers Association, Texas Bar Foundation, State Bar of Texas and Texas Association of Defense Counsel. He has won several awards in his profession, including: Presidents Award of Merit; Texas Young Lawyers' Association, 2005-2009; Bob Black Bar Leaders Award at Texas Tech University School of Law, 2018; Texas Super Lawyer's Rising Star, 2007-2011 and Texas Super Lawyer, 2014-2018. Chris is married to Sherry and they have two children; Madeline, 20 and Emma, 14. Chris will serve on the Grants Committee and the Bylaws Committee.



James Farren graduated from Tascosa High School in 1966. After a tour in Vietnam and a stint as a minister for the Church of Christ, Farren served as a police officer for several years. Farren then attended Amarillo College in the late 70's and went on to Texas Tech University, graduating Cum Laude in 1982. He then graduated from Texas Tech Law School in 1984.

Farren served as the Assistant District Attorney in Potter County for almost ten years and successfully prosecuted thousands of criminal cases in District Courts in Amarillo. Farren also prosecuted multiple criminal cases to conviction as an Assistant U.S. Attorney in the Northern District of Texas, The Amarillo Division. While serving in that capacity, Farren obtained convictions against twenty-two defendants in the largest drug conspiracy case ever tried in the Amarillo Division at that time.

In 1994, Farren was elected the District Attorney for Randall County. During his tenure, he tried more than 30,000 criminal cases. Farren led in the prosecution of a number of capital murder cases, including the trial of the first and only female capital murder defendant and a death sentence in the oldest pending capital murder case in the history of Randall County.

Farren was instrumental in the creation of The Bridge Child Advocacy Center in Amarillo. The Bridge became a blueprint for advocacy centers throughout the State and today, Texas requires all jurisdictions to provide such centers for child victims.

Farren joins a noteworthy group of past recipients of the AC Distinguished Alumni Award, a roster that includes, among others, such luminaries as JD Souther, an award winning composer and singer, Ben Sargent, a Pulitzer Prize-winning editorial cartoonist, U.S. Secretary of the Treasury, G. William Miller and the late Mary Lou Robinson, a federal judge who in 1973 became the first female appellate judge in Texas.

FREQUENTLY ASKED QUESTIONS

ABOUT ENDOWMENTS

1. How is an endowed fund established at Amarillo College?

An endowed fund can be started with a minimum gift of \$5,000. Additional contributions must be made to cause the fund to reach a total of \$10,000 within three years of the initial gift. Either one of our Foundation Co-Executive Directors can help walk you through the process of establishing an endowed fund

2. What is an endowment:

An endowment is a long-term investment in Amarillo College that provides benefits to students, faculty and programs year after year, generation after generation. An endowment is made up of gifts that are subject to a donor requirement that the corpus be maintained and invested to create a stream of income, with a portion of the average investment earnings expended to carry out the specified purpose of the endowment. To guard against the eroding consequences of inflation, the remaining portion of investment return is reinvested to help ensure that the endowment maintains its purchasing power over time to support future generations.

3. What is a corpus?

A corpus is the total amount that a donor gives to an endowment.

4. What is the difference between market value and book value?

The difference between book value and market value is unrealized appreciation (if market value is more than book value) or depreciation (if market value is less than book value).

5. Who will oversee my endowment in support of Amarillo College?

The Amarillo College Foundation board of directors and investment committee has legal fiduciary responsibility for endowment oversight.

6. How are endowment investments managed at the Amarillo College Foundation?

The funds are invested with our financial advisor and overseen by our investment committee.

7. How is spending determined? What is the relationship between overall investment return and the “spending” on an endowment?

Spending policies are set by the Board of Directors of the Amarillo College Foundation. The spending guideline is structured so that the funds available for scholarship, department and college support should grow over the long term without regard to the infusion of new funds; that is, the Spending Fraction should not exceed the expected rate of return on investments over the long term. This approach will provide for the control of scholarship spending while meeting the perpetual funding needs of the Foundation.

8. What happens to any “excess returns” in the endowment?

Earnings beyond the amount needed for spending are referred to as “excess returns” are added back to the principal and reinvested in the long-term pool to promote growth and protect against inflation for future programs. These excess returns are also used to provide funding for future spending budgets in down investment performance periods.

9. How soon will new endowed funds be available for expenditure for programmatic purposes?

It takes one year before there is enough interest and earnings for an endowed fund to be spent. Spending is not permitted from funds building to endowment level, unless there is a specific donation earmarked for current year spending.

Amarillo College has been the recipient of two national awards this year:

- **Leah Meyer Austin Award**

AC was voted the top community college for student success within the Achieving the Dream Network

- **Bellwether Legacy Award**

AC's No Excuses Poverty Initiative was selected as the Legacy Award winner in a competition between ALL previous Bellwether award winning programs

\$89.206 MILLION BOND REFERENDUM

The AC Board of Regents voted unanimously to approve a \$89.206 million dollar bond referendum on the upcoming May 4th ballot. The proposed bond package addresses the needs of the institution as outlined in the findings of a Master Plan study completed over the past eight months.

The Master Plan Study was undertaken by Parkhill, Smith and Cooper of Amarillo. The study recommends the following projects:

- Add additional parking on the Washington Street Campus and update wayfinding signage on the East, West and Washington Street Campuses
- Upgrade technology including virtual reality and robotics
- Comply with the Americans with Disabilities Act
- Upgrade infrastructure of aging buildings
- Centralize student advising and student life centers
- Create a First Responders and Public Safety Academy
- Develop an Innovation Hub for all aspects of business at the Downtown Campus

TRAVEL TO PERU

Amarillo College's Presidential Scholars describe their 11-day service learning trip to Peru as life-changing. The 13 travelers worked with *Peru's Challenge*, an organization for developing sustainable communities. They helped rebuild facilities at a school in a small village.

“My favorite part about *Peru's Challenge* was knowing that we were helping kids,” Mirian Gutierrez, a business administration major, said. “We got to meet the kids and see how sweet they were. It was amazing knowing that we were going to help their education.”

Other students said the highlight of the trip was the sightseeing. “My favorite part

was Machu Picchu because going to Machu Picchu was something on my bucket list that I've wanted to do for a long time,” Spencer Sopha, a psychology major, said. The Scholars spent the day at Machu Picchu hiking trails and exploring the Inca ruins.

The Scholars Program is designed to give high-achieving students the chance to participate in student-centered learning experiences that promote intellectual growth, cultural appreciation, leadership development and civic engagement. The program admits 15 new students each year. Along with international travel, the students receive scholarship funds from the Amarillo College Foundation.


