Dear Dr. Matney:

Thank you for your letter of March 23, 2009, conveying the additional information I requested concerning new programs added since the last reaffirmation, programs that have become inactive since the last reaffirmation, and clarifying the status of several off-campus instructional sites.

New programs

Certificates embedded in existing AAS degree in Nondestructive Testing & Evaluation

Surface Testing Technician (Jan, 2007)

Volumetric Testing Technician (Jan, 2007)

Nondestructive Technician (Jan, 2007)

AS in Pre-Physician Assistant (Aug, 2006) added as a transfer program within the Biology Department. Course requirements are very similar to the AS in Biology

Food Service Management AAS and certificate (Aug, 2007) added as a track within the existing management program

Food Service Supervisor certificate (Aug, 2007) another track within the existing management program Computer Information Systems AAS (Aug, 2008) Five existing degrees were collapsed into one degree with 5 tracks, as required by THECB

Radio/TV AAS (Aug, 2008) Two existing degrees were collapsed into one degree with 2 tracks, as required by THECB

<u>Discontinued programs</u>: programs that became tracks within a broader degree program as described above.

Closed programs:

Multimedia Production AAS (Aug, 2001) was replaced by AAS in Worldwide Web Software Development as of Aug, 2008. Students were allowed to complete the degree; faculty continue to teach courses in remaining programs.

Accounting AAS and certificate (Aug, 2006) students were given 3 years to complete required courses; faculty member continues to teach transfer courses in accounting.

Art-Multi Media certificate (Aug, 2004) students were allowed to complete required courses; faculty member continues to teach required courses in remaining art programs.

Auto Body certificates: 3 certificate programs were combined into a single certificate in Auto Collision Technology

Advanced Auto Body Technician (Mar, 2003)

Auto Body Assistant (Mar, 2003)

Refinish Technician (Mar, 2003)

Automotive-Diesel Fuel Systems certificate (Aug, 2006) students were allowed to complete the program or to transfer to the Diesel Mechanics program; faculty continue to teach in required programs.

Automotive-Basic Recreation Vehicle Technology certificate (Mar, 2002) was converted to continuing education courses; students were allowed to complete required courses; faculty continue to teach courses required in remaining programs.

Automotive-Auto Service Recreation Vehicle Technology certificate (Mar, 2002) was converted to continuing education courses; students were allowed to complete required courses; faculty continue to teach courses required in remaining programs.

Aviation Maintenance Technology certificate (Mar, 2005) was not recognized by FAA; students were advised to transfer into related programs. Students were allowed to complete required courses; faculty continue to teach courses required in remaining programs.

CDA Credential Option SHCT (Sept, 2007) courses were rolled into Child Development/Early Childhood Provider certificate. Students were allowed to complete required courses; faculty members continue to teach courses required in remaining programs.

Multimedia Production AAS (Aug, 2001) replaced by AAS in Worldwide Web Software Development Court Reporting closed due to low enrollments. Students were allowed to complete required courses; faculty members were redeployed into other programs or departments.

Court/Realtime Reporting AAS and certificate (Aug, 2002)

Caption Reporting Proficiency certificate (Aug, 2002)

Court/Realtime Reporting Professional certificate (Aug, 2002)

Criminal Justice Corrections AAS and certificate (Aug, 2008) Students were advised into other CJ majors; faculty continue to teach courses required in remaining programs.

Diesel Mechanics Technology-Basic Maintenance certificate (Dec, 2005) was dropped; students were advised into the revised Diesel Technician certificate program; faculty continue to teach courses required in revised program.

AS in Education (Oct, 2004) The following curricula were dropped when THECB developed a new AAT with options in General, Secondary, and High Need Education. Students were advised to transfer into one of the new AAT degree programs.
