Amarillo College does not use soft dollar arrangements, directed brokerage or directed commission, commission recapture, or similar arrangements.

Amarillo College is associated with the Amarillo College Foundation. The market value of the investments of the Foundation at 05/30/2020 was \$39,927,931.73. The investments are managed by the Investment Committee of the Foundation, P.O. Box 447, Amarillo, Texas 79178.

The Amarillo College Board of Regents reviewed, updated and approved the Amarillo College Investment Policy at the June 28, 2017 Board of Regents meeting.
