APA Examples for CINAHL Database

READ THIS: The main difference in citations for scholarly journal articles from library databases is the <u>number of authors</u>. See multiple-author examples in the next section.

In the text (examples). Authors must be cited in the paper and in the reference list. The citation requires the name(s) of the author(s) and the year. A citation for content quoted word for word also includes a page number.

The author's name can be included in a sentence as shown in this example:

According to Smith (2010), high-risk patients should be monitored regularly.

The author's name also can be included inside the parentheses with the publication year.

High-risk patients should be monitored regularly (Smith, 2010).

A verbatim quote also requires quotation marks and a page number.

High-risk patients should be "monitored regularly" (Smith, 2010, p. 3).

<u>In the references list (example)</u>. The example shown above illustrates APA style for a scholarly journal retrieved from a library database.

Note: Journal articles do not always have an **issue number**, e.g., "(1)" in this example.

Other tips:

- If an exact example is not available, find the closest example and modify it.
- Your paper and references list must be <u>double-spaced</u>.
- Deviations from the official APA *Handbook* were personally okayed by APA's style experts.
- Journal article citations from databases other than CINAHL will be the same except for the database name.
- <u>DOI (Digital Object Identifier) numbers</u>. Some articles have DOI numbers. If a DOI number has been assigned, it can be found in the article record in CINAHL. See the first example to see a citation with a DOI number.

In-text citation examples (in the body of the paper)

ONE AUTHOR, paraphrased content examples (two ways to cite it)

TWO AUTHORS, direct quotation examples (page number required for direct quotes)

- According to Jones and Harlow (2011), nurses who regularly encounter diabetic patients can play a "central role" in identifying early cognitive impairment (p. 427).
- Nurses who regularly encounter diabetic patients can play a "central role" in identifying early cognitive impairment (Jones & Harlow, 2011, p. 427).

Over →

THREE to FIVE AUTHORS (first and later mentions)

- On the first mention only, include all authors.
 - According to Fisher, Davis, McLean, and Le Couteur (2005), elderly patients living in an institutional setting such as a nursing home are at increased risk for falls.
- <u>For later mentions</u>, use the first author's name with "et al." ("Et al." means "and others.") Fisher et al. (2005) identified several novel potential risk factors for falls.

SIX or MORE AUTHORS (all mentions)

- According to O'Shea et al. (2010), high-risk patients should be monitored regularly.
- High-risk patients should be monitored regularly (O'Shea et al., 2010).

ONE AUTHOR, DOI number included (Some articles have the DOI, and some don't.)

TWO AUTHORS

THREE to SEVEN AUTHORS

EIGHT or MORE AUTHORS

Give the last name and initials for all authors up to and including seven authors. If the work has more than seven authors, list the first six and then use ellipses (. . .). After the ellipses, list the last author's name of the work.
